



# Artist Donates Paintings To MHQ

PAUL PENCZNER (MEMPHIS, DELTA ZETA '94) CONTINUES ARTISTIC TRADITION

In May 2005, artist Paul Penczner (Memphis, Delta Zeta '94) donated an artist's proof of his 1995 painting "The Last Walk" to the Pi Kappa Alpha Educational Foundation. Penczner did the painting after hearing that President Ronald Reagan was suffering from Alzheimer's disease. The image depicts Ronald and Nancy Reagan walking off, as Penczner describes it, into the



When presenting this most recent gift at the Headquarters, Brother Penczner posed for some photos in the Rotunda, where his portraits of the Fraternity's Founders are on display. Penczner was a special initiate of the Fraternity at the 1994 International Convention in Tarpon Springs, Florida. To understand his and his wife Jolanda's longtime friendship with Pi Kappa Alpha, it is important to know of their past. Penczner was born near Budapest, Hungary in 1916, was orphaned at age 11, and grew up in an orphanage. He was required to fight on behalf of the Hungarian army, which was a part of the German Axis in World War II. Initially he fought the Soviets on the Eastern Front where he was seriously injured. He was later transferred to the Western Front. a move which he believes saved his life, because in 1944 he was taken prisoner

of war by American forces. Following the war he applied for immigration to the United States, the approval of which took five years. While waiting he refined his artistic talents by drawing and painting landscapes, and portraits of war refugees and military officers. It was during that time that he met his German-born wife, Jolanda, who was interpreting for English speaking military personnel.

With the sponsorship of a prominent Nashville, Tennessee family, the Penczners immigrated to the United States in 1951. When their ship arrived in New Orleans, the son of the sponsoring family picked them up by car and started the trek back to Nashville. They stayed the night at a motel in Memphis and the Penczners awoke the next morning to learn that their ride had left without them. They believe their sponsor was concerned about whether Paul could make a living in the U.S. as an artist who spoke very little English; and whether Jolanda could find a job that would pay enough to support them both. There they were, with only each other and their life's possessions in their hands, in a strange city and feeling quite uncertain about their future in an unfamiliar land. They sought help from an employment agency, which sent Jolanda to an interview for a secretarial position with an executive for a small company; that executive was Robert D. Lynn (Presbyterian, Mu'31) and that small company was The Pi Kappa Alpha Fraternity. The Headquarters was in its temporary home on Union Avenue while the new building at 577 University

# Delta Beta Chapter Rechartered At Bowling Green State



On Saturday evening September 10, 2005, Delta Beta Chapter was rechartered at Bowling Green State University. The refounding group consisted of 56 outstanding gentlemen, and ranked the chapter as one of the largest at BGSU.

Prior to the chartering banquet, brothers from Beta Tau Chapter (Michigan), Delta Gamma Chapter (Miami-Ohio), Delta Nu Chapter (Wayne State), Epsilon Epsilon Chapter (Toledo) and a group of alumni assisted with the initiations. The initiations took place Friday afternoon and lasted long into the night. The installation of Delta Beta Chapter by International President Allen Groves (Stetson, Delta Upsilon '79) followed on the morning of Saturday, September 10, 2005.

The chartering banquet was held at Nazareth Hall in Grand Rapids, Ohio, and recognized the colony's accomplishments over the past 22 months. International President Groves was the keynote speaker, and provided the chapter with helpful advice and a warm congratulatory speech on their success over the past year. Another highlight was a film, displaying images of Delta Beta's past and present brothers, accompanied by a speech by Colony Recruitment Advisor Steve Daley (Bowling Green State, Delta Beta '86). Director of Recruitment Shawn Hutcherson (Florida State, Delta Lambda '01), former Expansion Consultant Eric Carr (Florida State, Delta Lambda '01) and Chapter Consultant Matthew Greco (Chapman, Theta Psi '03) joined alumni, parents and friends to honor and celebrate the rejuvenated chapter's accomplishments.

#### Colony to Chapter

In October 2003 Expansion
Consultants Eric Carr and Doug Cowan
(Missouri, Alpha Nu '00) ventured to
Bowling Green, Ohio with the goal of
building the most outstanding fraternity
at Bowling Green State. Despite the
challenges of being the new kids on
the block in a very competitive Greek
community, the colony persevered
and was approved for chartering by
an inspection committee made up of
Great Lakes Regional President James
Kanary (Michigan, Beta Tau '95) and
undergraduate representatives from
Epsilon Epsilon and Delta Gamma
Chapters.

Since its inception in fall 2003, the members of the colony have involved PIKE in every aspect of campus and Greek life. While still one of the newest fraternities on campus, the Pikes are influential in many ways, including involvement in Student Government, homecoming and varsity athletics. Delta Beta has donated more hours to community service than any other IFC group, totaling nearly 2,800 hours in a two-year span.

The chapter has grown to its impressive size through active, aggressive, year-round recruitment. Sorority recommendations and scouting the intramural fields were especially helpful to the chapter's phenomenal growth.

# Beta Xi Chapter Returns To The University of Wisconsin-Madison

On Saturday evening, October 8, 2005, the Fraternity welcomed back Beta Xi Chapter at the University of Wisconsin-Madison. Fifty men were initiated in the bonds of Pi Kappa Alpha, placing Beta Xi well above the average size of fraternities on the UW campus.

The four-hour-long initiation included men from Beta Eta (Illinois), Gamma Rho (Northwestern), Iota Delta (Rose-Hulman), and Kappa Omega (Wisconsin-Whitewater) Chapters, as well as many dedicated alumni. Initiation was followed by the chartering banquet held at Marriot Madison West. Guests included International President Allen Groves (Stetson, Delta Upsilon '79), Director of Recruitment Shawn Hutcherson (Florida State, Delta Lambda '01), Colony Recruitment Advisor Angelo Casino (Arizona State, Delta Tau '73), Colony Advisor Mike Hartwig (Wisconsin-Whitewater, Kappa Omega, '98), Student Activities Advisor Barb Kautz, and Ron Griesheimer (Illinois, Beta Eta, '55), whose son, Tom, was initiated into Beta

In his keynote address, President Groves challenged the chapter to focus on looking toward the future and to take advantage of the opportunity before them. This sentiment was echoed by many of the other speakers. In addition to the chartering celebration, Angelo Casino was recognized for his efforts with a distinguished service award from the

chapter, and Pat Garcia received the first annual "Pat Garcia

Award" named in his honor for outstanding brotherhood and service from an undergraduate member. The evening closed with Beta Xi presenting Memorial Headquarters with a painting depicting "the 5th quarter" tradition at UW football games.

Colonization

Consultants Eric Carr (Florida State, Delta Lambda '01) and Doug Cowan (Missouri, Alpha Nu '00) traveled to Madison in February 2004 to return Pi Kappa Alpha to prominence in Madison. While there were many obstacles along the way, the men were able to secure a number of recommendations of the best men on campus from the UW sororities and the men of Kappa Omega Chapter. As the dust cleared nearly a month after they arrived, 44 men stood as founding fathers of the colony. Nineteen months later, the Beta Xi name returned to UW.

#### **About UW**

The University of Wisconsin-Madison is divided into 20 associated colleges and schools. In addition to traditional undergraduate and graduate divisions in engineering, education, agriculture, and letters and sciences, the university also maintains professional schools in law, medicine, veterinary medicine, and pharmacy.

The College of Letters and Science enrolls approximately half of the undergraduate student body and is made up of 39 departments and five professional schools that instruct students and carry out research in a wide variety of fields such as biology, astronomy, history, and sociology.

Wisconsin has been one of the leading public universities in the United States since the beginning of the 20th century and ranks as one of the great research universities of the world. Among U.S. universities, the University of Wisconsin is frequently listed as one of the "public Ivies"—publicly-funded universities providing a quality of education comparable to the best private schools.

In addition to being a highly-ranked school in education, geography, history, and sociology, the university was recently ranked the second-best college at which to earn an education degree, and the overall seventh-best public school in the United States.

#### Armstrong Atlantic State University: Pike's Newest Colony

The Supreme Council is proud to recognize Pi Kappa Alpha's newest colony at Armstrong Atlantic State University.

Located in historic Savannah, AASU is part of the University System of Georgia. It was founded in 1935 as Armstrong Junior College and received university status and a new name in 1996. The university community includes 7,000 students and 290 full-time faculty. New student housing on the 268-acre campus aids in its evolution from a commuter campus to one more traditional. Armstrong was a host to Pi Kappa Alpha's Eta Mu Chapter from 1970 to 1982, and as of October 5, 2005, the Fraternity and University have renewed this relationship.

Consultants J.R. Parsons (Wyoming, lota Alpha '01) and Ben Boden (lowa State, Alpha Phi '01) spent four weeks in Savannah conducting the referral-based expansion project.

After conducting over 200 student meetings, 51 invitations to become founding fathers were extended. The colony has more than twice as many men as its nearest competitor and is the largest undergraduate student group on campus. The membership

includes three Eagle Scouts, four residence hall advisors, two members of the student government association, four campus union board chairmen and the vice president of HOLA (a prominent Hispanic student organization).

The colony has already demonstrated its potential, recruiting four more men within a week of its formal colonization. With the continued support of local alumni and university administrators, this new colony should prove to be a dominant force on the growing AASU campus.

#### Clemson University

Expansion consultants from the Pi Kappa Alpha Headquarters will arrive in Clemson, South Carolina in mid-January and will remain on campus through mid-February, 2006, recruiting men to form a colony. AK Alpha Kappa (Missouri-Rolla)

Active chapter size: 89. The chapter sent four men to The Academy in 2005. Alpha Kappa Chapter celebrated its centennial with their largest alumni gathering ever (see story, page 34). They were awarded the Organizational Community Service Award in May 2005 by the student council. In community service, they raised over \$1,000 to aid the victims of Hurricane Katrina, and have planned a weekend trip to North Kansas City to help repair and maintain a wilderness camp. The chapter has a goal to complete 12,000 community service hours this academic year. Each member of the chapter participates in on-campus organizations, with Pikes currently holding 16 officer positions in those organizations. They also have 22 varsity athletes. In May 2005, the chapter received the Order of Omega Gold Award. This fall, Alpha Kappa placed first in Homecoming among fraternities.



Thank you so much for hosting the benefit concert for the Hoosier Hurricane Relief Fund. The fund is a joint effort between eXchange at Maryland Community Church and Kings Highway Family Life Center. The money raised will be going to fund trips to various locations in the affected areas or as direct financial assistance to the people affected. We have already made several trips down to Louisiana. On the first trip we delivered two 24' box trucks loaded with food and supplies to a refugee camp in Alexandria and to a church in Baton Rouge serving as a distribution point for the Red Cross. On the last trip a group of men from Kings Highway helped a family clear debris from their home and presented them with a check for \$5000. A few men are going back down to do some drywall work very soon. The trip cost us about \$600 which is just a little less than what was raised by your fundraiser. So in essence, your fraternity is funding an entire relief trip.

On a personal note, I want to say how impressed I was with the quality of the Pike men. As a fraternity guy myself I am proud to see you handle yourselves with class. #### Wilfrid Laurier Pike Climbs Kilimanjaro

In August 2005, along with the PiKA flag, I ventured off to Tanzania, Africa, with one goal in mind – to climb Mount Kilimanjaro. So on August 11th, I set off for what would be the trip of a lifetime. I arrived two days later to start my trip.

Mount Kilimanjaro is situated right on the border between Tanzania and Kenya, and at 19,336 feet, is the highest point on the African continent. The climb goes through five different ecosystems, and takes 6 days in total. The temperature ranges

from 30 degrees Celsius at the base of the mountain to -25 degrees at the top.

The climb starts off in a dense rainforest, where wildlife and thick foliage thrive. As you progress higher up the mountain, the forestation and the oxygen levels both begin to thin. At 12,000 feet, the animal and plantlife have all but disappeared, and the only thing still living is the occasional bush or small bird. The reason for this is that the higher altitude yields less and less air to sustain any form of life. The effects of altitude take their toll on people, too, where AMS (Acute Mountain Syndrome) and cerebral edema become a very real risk for climbers.

The risks are far outweighed, however, by the unparalleled views. At 14,000 feet, I was far above the clouds. To look down this massive expanse of a mountain and see the clouds moving far below was truly mesmerizing. Looking up the mountain, I was awestruck to see the two impressive peaks of Kilimanjaro standing in front of me. I took this opportunity to take many pictures of myself standing proudly with the Pike flag, with either the peaks of the mountain or the clouds far below as my backdrop.

Before my surroundings had really begun to sink in, it was already time for the final leg of the ascent. I was faced with one daunting task – get the flag of my Fraternity to the highest point in Africa. Getting to Uhuru Peak is by far the hardest part of the climb. The goal

is to make it to the very top at sunrise, which provides for a beautiful photo opportunity. That requires starting to climb at 11:30PM the night before. At this point, the oxygen level is only 50% of what it is at sea level. The weather is also bitterly cold, where temperatures average -25 degrees before accounting for the windchill factor. So in the pitch dark, with only the light of the moon to guide me, I started my arduous climb to the top. I doubted myself every minute of the way, and I can honestly say that it was the hardest thing I had ever done in my life. Eight painful hours later, I had made it to the summit. Reaching the top was a very emotional experience, but I pulled myself together to do what I had come to do – take some photographs with the Pike flag at the highest point in Africa.

Overall, climbing Kilimanjaro was an extremely rewarding experience that was as challenging mentally as it was physically, which will impact me for the rest of my life. I am proud to say that I brought a symbol of Pi Kappa Alpha with me on my journey.

#### Gamma Chi Chapter Claims 2005 House of the Year Honors

Gamma Chi Chapter at Oklahoma State University was the recipient of the 2005 House of the Year Award at the Academy. Through the strong leadership of their house corporation and continued alumni involvement, Gamma Chi has ascended to the elite class of Fraternity real estate.

The J. Lewie Sanderson Chapter House is located at 221 South Lincoln in the heart of the Oklahoma State University campus. The beautiful English Tudor style facility was originally completed in 1965. Over the years, renovations and additions, including a \$240,000 project completed in 2004, have transformed today's structure into a 12,500 square foot mansion with a capacity of 70 men. The house boasts a fully functional commercial kitchen, house mother's apartment, a tastefully appointed formal and trophy room, lounge, and a social hall.

The Paul A. Crawford Memorial Library, named in honor of one of Gamma Chi's late brothers, is a source of extensive pride for the men of Gamma Chi Chapter. Located on the top floor of the house, it

is beautifully furnished and contains an extensive collection of books, documents, and files. In addition, Gamma Chi is one of Pi Kappa Alpha's only chapters to have its own Alumni Hall of Fame.

# Gamma Chi Chapter's Award Winning Chapter Management Practices:

- Gamma Chi has an exceptional house manager program and committee. The house and kitchen manager work together to schedule cleanings and complete major projects. Each member of the house committee has specific job duties and responsibilities.
- The chapter's house manager is responsible for supervising the kitchen, administering a comprehensive maintenance program, management of a housing



committee, assigning daily/weekly cleaning duties to all members, and conducting periodic room inspections to ensure safe living conditions.

- The chapter has a written lease with their house corporation and the house corporation charges a rental rate that doesn't fluctuate with actual occupancy.
- Gamma Chi maintains written room contracts for all tenants and charges a market rental rate. By charging a rental rate that is competitive with on-campus residence hall living, the chapter and house corporation are able to properly maintain their house and build reserves for the future.
- Gamma Chi has adopted and enforces by-laws, policies and house rules pertaining to the treatment of the facility. There are documented procedures for filling out damage and repair reports. By-laws stipulate a live-in requirement in order to maintain full occupancy of the property. If there is a house vacancy, by-laws specify which individuals are to fill this void.
- The chapter requires a security deposit for all tenants. In addition, the chapter has in place a series of fines pertaining specifically to housing issues including damage, destruction, and violation of quiet hours.

The house corporation and the undergraduate chapter have an excellent relationship with outstanding communication which aids in their successes. Gamma Chi's executive council and house corporation meet regularly and discuss matters in an open sense.



#### Eta Omicron Takes Improvement Project of the Year Honors

What began innocently enough as the planning for another great International Work Day grew into one of the largest, chapter funded improvement projects any chapter has undertaken in recent history. Eta Omicron Chapter at the University of Louisiana-Monroe has always taken Work Day very seriously. It is not uncommon for the group to stretch the event into a week long extravaganza involving alumni from every generation of the chapter and completing literally dozens of projects, but this year would prove to be a whole new level.

In March 2005, Eta Omicron's house corporation learned that another fraternity at ULM would be closed. This was of particular interest to Pike because that group was currently leasing Eta Omicron's second house. When the house corporation went to inspect the property after the former group moved out, what they found was quite a surprise.

To say that the once proud, former Pike house was in total disarray would be an understatement. The property had significant drywall damage throughout, literally hundreds of nail holes, and some broken windows. The former tenant had painted its insignias on every wall possible, even cutting holes in the ceiling so that extension cords could be run to put lights on their crests painted on the chapter room and kitchen walls. Any wall lacking a poorly done mural was painted and trimmed in that fraternity's colors. The former tenants seemed to vent their

frustrations on the building before giving it up.

Both the front yard and the sidewalk had letters embedded in the concrete. The tenants had climbed on the roof so many times that they had broken the overhang of the shingles the entire way around the house. Finally, unwanted personal items were destroyed and left for the owners of the house to clean up.

So began the work for Eta Omicron. The chapter and alumni spent six weeks and over 640 combined, well-documented man-hours working on the property. Brothers spent time after class, on the weekends, and after work until midnight on a labor of love. They used everything from a shop vacuum on cigarette butts to a power washer on the exterior of the house to elbow grease throughout to bring the property up to a standard suitable for Eta Omicron.

Some of the larger work included replacing all the carpet inside the facility. Water damage caused not only the carpet and floor to rot in one spot near the back deck, but a 16-foot section of the floor joist had also rotted and formed a sink hole. Active brothers and alumni utilized their plumbing and electrical expertise to repair leaky sinks and toilets and replace faulty outlets and life safety equipment.

The new "old" Pike house, coined "2 Pike," will serve the chapter as an annex property. The chapter members decided then and there to step to the plate and fill the property for betterment of Pi Kappa Alpha. Immediately, men started to work on terminating their existing leases and making arrangements to move back to their old home. Eta Omicron was successful in filling not only their first

house, but a second one too.

Over \$10,000 went into the projects, completely funded by the chapter, house corporation, and generous alumni who gave not only of their wallets but of themselves. Chapter Advisor Tommy Walpole '80 said it best when he wrote, "this was more than a chapter improvement project, this was a reclaiming of something that had helped us get to where we are now – it was owning up to our responsibilities as brothers – it was about pride – and it was about our future."

The brothers of Eta Omicron are applauded for their accomplishments in 2005. The motivation and commitment of their members and alumni to accomplish this project exemplifies the mission of Pi Kappa Alpha and serves as a model for all chapters. # Legends of Delta Lambda


PIKES' COMMITMENT AND ENTERPRISE BUILD THE BIGGEST AND BEST FRATERNITY HOUSE IN THE COUNTRY

It was an ambitious, yet simply stated goal: Build the Biggest and Best Fraternity House in the Country. The Florida State Pikes have a long tradition of excelling in everything they set out to do; therefore, a goal to accomplish anything less would have been out of character for the proud members of Delta Lambda. Completed last spring, the new Pike House was formally dedicated on October 1, 2005. It was one of the most successful capital campaigns and grandiose real estate endeavors ever undertaken in the fraternity world.

The entire project, Legends of Delta Lambda, was founded by a handful

of passionate and dedicated alumni including Brent Sembler '78, Andy Miller '70, Charlie Barnes '65, Ken Marks '80, and Doug Russell '78. Upon the extremely successful recolonization of the student chapter in the spring of 2000, followed by the rechartering a year later, ending a 13-year hiatus from campus, these alumni wanted to provide the chapter a new home that would help solidify the re-born chapter's strong stature, which had been the defining attribute of Delta Lambda's reputation for so many years. To minimize the need for financing, they knew that the cost of such a facility would require a highly prosperous capital campaign.

The professional fundraising firm of Ron Rietdorf & Associates (now Omega Financial), an approved vendor of the Fraternity, was selected because of their successes with other fraternity campaigns at FSU. A feasibility study, based upon their conceptual plan, determined that the group could raise at least \$2 million. Brothers Sembler and Marks became the chairman and vice-chairman of the campaign. In addition to those already mentioned, other members of the leadership team included Harry Sargeant '78, Mike Fernandez '77, Jesse Vance '80, Eddie Allen '79, Stephen Smith '78 and Allen O'Brien '79. The house corporation started out with only \$17,000 in reserves;

and in the midst of the feasibility study, the terrorist attacks of September 11, 2001 occurred. The uncertain economic landscape made an accurate assessment of their potential difficult. However, principle of the fundraising firm Ron Reitdorf laughed as he described his experiences interviewing alumni during the feasibility study, "This was the most belligerent bunch I've ever dealt with. We'd visit guys in their offices, and nearly every one of them said, 'I'm in as long as it's the biggest, most impressive house on campus; if it's not then count me out'."

While there were many obstacles to overcome, Delta Lambda could count on one significant advantage: the generations of alumni who shared a powerful identity with the chapter. "This is the thing that's really unique about them," said Reitdorf, "For maybe forty years the chapter and the alumni have shared a single theme, a single specific identity. If that doesn't already exist among alumni, you can't recreate it with campaign materials. The Pikes at Florida State possess this to an extent unlike anything I've ever seen."

Under Reitdorf's guidance, the leadership team conducted an intense 12-month campaign that exceeded its original \$2 million goal by over \$500,000. To date, there have been 250 cash pledges and gifts in kind. They overcame many

obstacles including four hurricanes to complete construction in just 16 months at a cost of nearly \$4.5 million. There have been seven individual leadership gifts of \$100,000 or more, and two of \$50,000.

At the groundbreaking ceremony on September 20, 2003, campaign chairman Sembler addressed a large crowd of alumni and undergraduates, saying, "There's no doubt the bar was set very high, but Delta Lambda has a history of overcoming adversity and setting the standard for others to follow. I was fortunate to be surrounded by exceptional leaders – friends and brothers all

– who not only wrote the checks, but made the calls that inspired other men to do the same."

The Pi Kappa Alpha house is located at a prominent location in Florida State's new Heritage Grove, a 37-acre Greek housing development on State land, assembled via a venture between the County, the University, and the Greek organizations that will occupy the real estate. The Grove consists of 13 Greek facilities, eight that rent individual units from the Leon County Educational Facilities Authority and five that own their own buildings with long-term ground leases. Pike is one of the five with an equity stake in their improvements. Ample parking lots serve the entire development and there will be a communal club house with swimming pool and recreation courts for all Heritage Grove residents to share. The development is linked to the main campus via a 3/4-mile wooded bicycle/ walking trail, and is served by buses on a daily schedule.

The two-story Greek revival structure is believed to be the largest fraternity house under one roof. It features 30 residential living units, each of which is a self-sufficient apartment with a kitchen and living room. There are 29 two-man units containing two bedrooms and two bathrooms each; and one singleman unit with one bedroom and bath.

One of the two-man units is the President's Suite, which consists of more living space than a typical unit and also contains an office and one interior balcony that overlooks the front entrance foyer and an exterior balcony that overlooks the courtyard in back. Sixteen of the units have either a balcony or porch, depending which level they are on, that goes out to the courtyard in back.

The foyer is two stories tall, lined with trophy cases, and is flanked by a formal sitting room on one side and a social hall on the other.

The sitting room is called The Legends Room, which is tastefully appointed with chapter memorabilia.

The other side of the foyer leads to a large banquet type room, named Sembler Hall, which is adorned with a hardwood floor and opens out to both the front and rear of the building. Off Sembler Hall is a media room with a big screen TV, high performance sound system,

and electronic games that help draw members together for recreation when in the facility.

The residential parts of the structure are divided into five "scholarship houses" – each named for a key donor. Each contributor's name appears in bronze letters on the exterior of the respective

portion of the building: Roix House, Williams House, Miller House, Sargeant House, and Vance House. Each set of 12 residents in a "House" are assigned a number of nonresident Pikes to be members of that Scholarship House. This structure helps facilitate communication and provides a network for healthy competition among members.

The Legends Campaign of Delta Lambda has set the high water mark for Pi Kappa Alpha capital campaigns. Congratulations to Delta Lambda for completing this tremendously successful project, of which all Pikes can be proud.

#### **Myths and Legends**

This section highlights Pi Kappa Alpha's most captivating housing stories of the past and present. If you have an intriguing story that you would like to see published, please contact the Real Estate Department.

#### Pi Kappa Alpha: Texas-Sized

This edition's legend hails from the Lone Star State where a Texas-sized property was essential to fill the needs of Zeta Theta Chapter. In 1969 Pi Kappa Alpha became the first fraternity to own a fraternity house on the campus of what was then known as Southwest Texas State College.

The property located at 1132 Belvin Street was purchased by the House Corporation from the American Legion for the sum of \$36,500. Built in 1906, the three-story brick structure boasted an area of 11,286 square feet and stood on a massive six and one half acres of land. It was accounted in the 1968 San Marcos Record as having "a front yard that occupies almost as much area as a regulation football field". The house featured a full porch stretching across the front of the first two levels, an elevator and accommodations for 40 men.

The facility was originally designed by W.N. Hagy in a Colonial Revival style of architecture, with Victorian influences, for the Coronal Institute. Coronal was founded by Orlando Newton

Hollingsworth in 1868 as a private, coeducational school that offered military training to boys. The building that later became known as the Pi Kappa Alpha mansion was first named Fisher Hall, for one of the Institute's influential presidents. On June 26, 1875, the San Marcos district of the Methodist Episcopal Church purchased the school and building as well. In 1923 it was purchased from the Methodist Church and converted into a hospital as a memorial to the World War I veterans of Hays County. It retained that use until 1963 when the American Legion bought the property and leased it to the Baptist Academy as a boys' dormitory, and was used as such until Pi Kappa Alpha took ownership in 1969.

The surgery room, with its nicely tiled floors and walls, served as a large community bathroom and showers. The waiting area on the first floor made for an accommodating living room and the size of the individual hospital rooms served the dorm room purpose quite well. The

large front porch and balcony above was an inviting place to relax and look over the massive front lawn. Whether it was an infirm veteran who took his last breath while appreciating the view, or the passing of other hospital patients, it is there that on many a quiet southwest Texas night, Pike brothers would hear the sounds of unidentified footsteps on the balcony. The roof of that same balcony, some years later, was nicknamed "South Pike Island" as young sorority girls would frequently sunbathe on a sand covered roof after a long afternoon of class.

Zeta Theta has one of the most storied histories of all Pi Kappa Alpha chapters. Originally founded as the Harris-Blair Literary Society, former U.S. President Lyndon B. Johnson was a member of the local organization that eventually became Pi Kappa Alpha. Some of Zeta Theta's history remains unique due to its first house. Some of its members, as well as the immediate past executive director of Chi Omega Sorority, Lisa Morgan, were actually born in the house.

Ultimately in 1997, the house was sold and the chapter moved into a newer and arguably more practical facility. The property remains at 1132 Belvin Street, having been landmarked on the National Registry of Historic Places in 1983.

# Educational Foundation Partners with Kansas State Pikes To Renovate Alpha Omega Chapter House


The Pi Kappa Alpha Educational Foundation and Alpha Omega Chapter Housing Corporation are nearing completion of a partnership that has raised nearly \$1.1 million to renovate the Pi Kappa Alpha chapter house at Kansas State University.

Utilizing the Educational Foundation's Educational Facilities Grant Program, KSU Pike alumni were able to channel a significant percentage of campaign dollars through the Foundation, and thereby provide substantial tax savings to alumni generously supporting this effort.

As its name implies, the Foundation's Educational Facilities Grant Program allows alumni to underwrite capital and facility improvements that are exclusively educational in nature and that accordingly, enhance the academic endeavors of Pi Kappa Alpha chapters and their members.

Mike Riley (Alpha Omega '84) serves as president of the Alpha Omega House Corporation. "Without question, the Foundation's Educational Facilities Grant Program made the difference in helping us reach our campaign goals. Offering tax deductibility to our alumni, particularly in the initial stages of the campaign, really helped us achieve early, vital momentum with this effort," Riley commented.

With these substantial upgrades to Alpha Omega's chapter house, its alumni are now focusing on how best to employ these improved educational facilities to further enhance the chapter's efforts to excel academically. The Alpha Omega Chapter Alumni Association has embraced rigorous academic goals and standards for the chapter, including



a heightened emphasis on academics in rush, chapter house study hours and financial incentives in the form of scholarships for student members who excel in the classroom. Riley adds, "Now that we have a physical facility of such high caliber, we are turning our attention to the enhancement of programs and incentives that help us recruit and build young men of whom we can all be proud, both for their efforts on campus – and in the classroom."

Qualified uses of funds from an Educational Facilities Grant include both actual educational products like study desks, computers, peripheral products and the like, and the establishment or enhancement of dedicated educational areas within the chapter house including libraries and study rooms. The key caveat is that the use of these products and physical facilities must remain exclusively educational in scope and use. In other words, a new chapter house library or study area funded through this program cannot also serve as a facility for regular chapter meetings, as a dining hall, or for other, non-educational purposes.



# Alpha Kappa Chapter

### Celebrating 100 Years of Pi Kappa Alpha at the University of Missouri-Rolla

t the dawn of the 20th century, Albert Einstein was shaking up the scientific community by discovering what would become the basis of three fundamental fields in physics: the theory of relativity, quantum theory and the theory of Brownian motion.

In that same "miraculous year" of 1905, William A.
McTighe and Faris T. Walker, two students at the Missouri
School of Mines (now University of Missouri-Rolla), would help chart a course for a new future for the Pi Kappa Alpha fraternity, one that included a chapter above the Mason Dixon Line.

On November 28, 1905, the national Grand Princeps Arthur C. Jones and Grand Treasurer Robert A. Smythe sent W.G. Riddick of Little Rock, Arkansas, to investigate the MSM applicants.

"It was easy enough for me to see of what material they were made," writes Riddick as he describes meeting the eight students. "It has never been my good fortune to meet a finer crowd of men, and certainly I never had a better time than during the first few short days that I spent with them. After the Chapter had been installed, after I changed into only a visiting alumnus, and there was nothing to do but say 'good-by' and go back home, I felt like I was leaving my old college and my old Chapter."

### A Bright Future

Don Myers '58, a 1961 graduate and chair of the chapter's centennial committee, welcomed 220 alumni, 110 members and pledges, and more than 180 friends and family to the UMR campus on Saturday, October 1, 2005 to celebrate the chapter's 100th anniversary.

The celebration planning officially began at Founders Day in 2003 with a meeting of designated chapter members and interested

alumni with a total of 15 attendees. At about the same time a formal agreement was entered into with the author of the Alpha Kappa History.

"The history was seen as a significant component of the overall Centennial Celebration," Myers says. "The collective vision of the planning committee was for a fabulous celebration of 100 years of brotherhood specifically for Alpha Kappa and to celebrate brotherhood in general."

The committee reached consensus to have the celebration at the UMR 2005 Homecoming, a general concept of the weekend activities, and the plan for a network of alumni contacting other alumni. This network was to be organized by "decade" coordinators who in turn

would work with their "class" coordinators.

"Thanks to excellent work by David Hill '04, chapter computer guru, a page on the chapter website was devoted to the Centennial Celebration," Myers says. "Information was made available and continuously updated over the two and a half years. Alumni commitment to a 'plan to attend' was requested and encouraged. A list of alumni planning to attend was maintained on the centennial webpage."

Information was also provided in quarterly alumni publications. The challenge was to try to determine the number of attendees for facility planning. The goal established at the initial meeting was 650.

The weekend entertainment included Friday and Saturday afternoon social hours and house tours, and a two-hour program on Saturday at the Leach Theatre (named for Thomas Leach, Alpha Kappa '15) that took guests back like a time machine through Alpha Kappa's history, beginning with a re-enactment of the fateful 1905 meeting between the founding members and Riddick. That was followed by four more skits depicting specific decades (50s and 60s, 70s and 80s, 90s and 00s, and vision for the future)

and an emotional 21-minute DVD show of pictures set to appropriate background music, developed by graphic artist Angi Yowell, depicting the Alpha Kappa history. The slide show also highlighted the more than 50 years of service to Alpha Kappa by the late Robert V. Wolf '48, professor emeritus of metallurgical engineering at UMR, and long time Alpha Kappa Chapter advisor. Following each skit, five alumni lead the attendees in singing favorite PiKA songs of the particular decades depicted.

The skits included activities that were in many ways unique to the particular decade but to which all alumni could relate. Emphasis

was placed on "entertaining" with some liberties taken relative to the facts. The 50s and 60s skit used a favorite party week at that time known as "Bum's Brawl" for a setting to remind alumni of the issues the chapter was facing at that time because of insufficient house capacity.

The 70s and 80s skit used a setting of brothers' early morning attempt to wake a fellow fraternity member using unconventional means in the fraternity house's sleeping quarters. This setting was used to discuss the various unique aspects of the annual campus St. Pat's celebration, and the scholarship dinner where individuals with high academic achievement for the semester ate steak and the others ate beans.

The 90s skit was focused on the 1999 fire that destroyed the chapter house and took the life of Brother Jered N. Adams '97, along with the rebuilding and dedication of the new house. This slide presentation was narrated by Brother Ryan Stockamp '98, who was the first to discover the fire.

The final skit used a setting of the biannual officer and alumni organization directors retreat to discuss the issues related to the vision of the future for Alpha Kappa. PiKA International President Allen W. Groves (Stetson, Delta Upsilon '79) dropped in on the meeting (skit) to share the vision of International.

The celebration continued from the program directly to the Grand Centennial Banquet held at the recently finished Havener Center on campus. The affair included a welcome address from each of the four Alpha Kappa entities, recognition of individuals, comments by International President Groves, and the distribution of \$16,000 in awards to undergraduate members in the areas of academic achievement, leadership, and rush.

### Treasuring The Past

The celebration also included the unveiling of a 300-page book on the chapter's history. Each alumnus will receive a copy of the book, titled A History of the Alpha Kappa Chapter of Pi Kappa Alpha 1905-2005: 100 Years of Brotherhood. "Through Melody Lloyd's writing and research skills, she was able to reassemble our past through words and pictures. She worked directly with International Headquarters, the UMR archives, the MSM-UMR Alumni Association, and many AK alumni to locate much of our history lost in the tragic fire of 1999. The book truly covers our chapter's interesting history," commented the Alpha Kappa project leader

We wish to thank Brother Smythe for his promptness in assisting us to organize our Chapter. We feel that the success of our undertaking is due to the interest and help he had given us in this matter from the start.

"Alpha Kappa alumni treasure their belief in the Fraternity's preamble and are determined to maintain and enhance brotherhood for all present and future brothers," Myers says. "Alpha Kappa takes great satisfaction from recognitions by and contributions to the international efforts in the past 100 years."

Alpha Kappa and its members have received 14 Smythe awards (including 2004 and 2005), four Powers Awards, and Chapter House of the Year in 2003. It has had three national/international vice presidents, one national rush director, and four district presidents.

Alpha Kappa has recently celebrated the addition of two new entities: The Alpha Kappa Educational Foundation, which received IRS approval in 2003, and the Alpha Kappa Alumni Association which received its charter at the 2004 International Convention in St. Louis, Missouri. Since Founders Day 2003, the combined effort of the alumni entities has awarded almost \$100,000 in scholarships to undergraduate members in the areas of scholarship, leadership, community service, campus involvement and rush.

The chapter has grown to over 100 members and pledges total, a size that enables it to successfully compete in all phases of campus life. The management focus of the chapter has indeed shifted because of the difficulties associated with maintaining brotherhood when housed

in various locations, as compared to under one roof. The biannual officer transition retreats have helped plan and navigate this new environment.

"The four entities – Active Chapter, Alpha Kappa House Corporation, Alpha Kappa Alumni Association and Alpha Kappa Educational Foundation – now all work in concert to assure Alpha Kappa's success in the future," Bauer adds.

# News of Bygone Days

125 Years Ago... Alpha Chapter (Virginia) indicated discouragement by a lack of interest in pledging, initiating only two members during the fall of 1880 and only three during the entire session. Very soon, Alpha was writing to Theta (then Southwestern Presbyterian, now Rhodes) suggesting a merger with some other national fraternity. In reply to Alpha's discouraging suggestion, Theta passed a strong resolution stating that she would not merge with any other organization, but would take on herself the responsibility of carrying on the Fraternity and asked Alpha to send the complete records



75 Years Ago... The December 1930 issue of Shield & Diamond marked the 40th anniversary of the Fraternity's magazine. Begun in 1890 as the Pi Kappa Alpha Journal, the magazine had been guided by six editors: Robert Adger Smythe (Citadel, Lambda 1889), Walter Garrett Riddick (Washington & Lee, Pi 1901), Charles Walton Underwood (University of the South, Chi 1903), P. Tulane Atkinson (Hampden-Sydney, Iota 1904), Henry L. Hammett (Tulane, Eta 1914) and J. Harold Johnston (Rutgers, Alpha Psi 1916). The December 1905 magazine reflected on the issue of recruitment: "Once again the chapter correspondents have the chance,

in sending in news matter for this issue, to announce to the world at large that their chapters had pledged the 'cream of the

freshman class.' ...we are glad that the chapters feel as they do about their new men. It must stir again the enthusiasms of alumni who read the news from their chapters, for who of us does not remember the first day we appeared on the campus with the little white button in our lapel?

We would like to extend the right hand of congratulation to each one of these young men on the threshold of his

life in TIKA, for somehow there's a thrill in seeing his eyes brighten as he contemplates what is to come. Not being able to see each one, the best we can do is this word of greeting. May you enjoy your association with the wearers of the Garnet and Old Gold and, in turn, may your chapter be forever proud of your selection. It's a mutual relationship."

50 Years Ago... The December 1955 issue of Shield & Diamond contained an article by National Historian Freeman H. Hart (Hampden-Sydney, Iota 1928) recounting how various items of Pi Kappa Alpha's history were donated by Founder William Alexander: "While [Alexander] was talking somewhat indifferently, he was subconsciously 'doodling'. A glance at the 'doodling' seemed to indicate that it was the badge of Pi Kappa Alpha and it proved to be just that. On request, he turned it over to his interviewer ... "Also, "the beautiful mahogany office furniture which was used by William Alexander for a number of years" was donated to the national office.

25 Years Ago... In November 1980, former Headquarters staffer and regional president Ed Pease (Indiana, Delta Xi '71) won election to the Indiana state senate. Pease acknowledged the support of the men of Theta Omicron Chapter (Indiana State), who knocked on an estimated 180,000 doors in Vigo Country where Pease won 65 percent of the vote.



## Dick Blankenbecler (Delta Gamma '51)

MIAMI UNIVERSITY ALUM'S CAREER STRETCHES FROM CARNIVAL TO STANFORD

**Dr. Richard Blankenbecler** is a highly regarded physicist specializing in algorithmic science and is the former head of theoretical physics at Stanford University. He is particularly well known in the scientific community for his work on light bending in glass.

Dr. Blankenbecler has had an interesting and distinguished life and career. We present here some highlights, in his own words.

"I was born in the hills of Tennessee, a true hillbilly at heart. After graduating from high school, a friend and I took off hitchhiking for the Midwest. We ended up in De Kalb, Illinois, for a promised job at a packing plant. Unfortunately, it was a ruse - they only needed field workers, pea pickers, at low wages. That didn't appeal to us so we searched for alternatives. After some thought, we bought some supplies, cut out number stencils and went into the business of painting house numbers on curbs. It took a while to drum up business, but eventually we were doing fine while living in the migrant workers camp. Then a traveling carnival came through town, offered us jobs, and I became a carny. I was a jenny-man, i.e., ran the merry-go-round. We stayed in a small town for a week, packed up, drove for a few hundred miles and started again. We were eventually fired for giving rides to kids without the price of a ride.

That fall, 1950, I started at Miami as physics major. I pledged Pi Kappa Alpha and eventually became a brother. The maturity of the members of the chapter (many were WWII veterans) was an important factor in my choice. I formed a jazz group playing piano and vibes. We played weekends in and around Oxford, Tuesday and Thursday afternoons at Mack and Joe's, and had a steady job at a road house in Dayton.

I meet my future wife, Lois Main, on a blind date at Tuffy's. We were married between our junior and senior years. I worked at Armco Steel Corporation in Middletown during this last year – leaving Oxford at noon for the commute.

After we both graduated, class of 1954, we were off to California where I took up graduate study at Stanford and Lois started her teaching career. I spent a year working with Robert Hofstadter, who later won the Nobel Prize for his work. In spite of the fact that I am the world's worst experimentalist, I measured the size of the helium nucleus and first proved that the neutron is not a point, but has

a finite charge radius. I received my degree as a theoretical physicist in 1958.

I won a
National Science
Foundation
postgraduate
fellowship and
went to Princeton
University.
I joined the
faculty and was

awarded tenure four years later. Princeton was a wonderful place to teach and to do research. I am very proud of the excellent graduate students that I had through the years. Many have gone on to important positions in academia at top universities, in the government, and even international banking!

One of my top memories was a
Tuesday lunch discussion group that J. R.
Oppenheimer organized at the Princeton
Institute for Advanced Study, in his study
and on his dime, for a half dozen local
theorists. During the period of the 60s,
I was invited to join JASON, a scientific
advisory group to the government. Certain
of their defense activities are described,
some even correctly, in the infamous
book, *The Pentagon Papers*. Among the
perks as I recall was a protocol rank of
general/admiral whenever we visited a
military base. Actually the treatment was
uncomfortable for the son of a private.

In 1967 we went on sabbatical to the University of California at Santa Barbara and eventually decided to remain on the west coast. I accepted an offer to become a theory professor at the Stanford Linear Accelerator Center in 1969. I served as the head of the theory group for about 10 years during my 30+ years at SLAC. I retired in 2003 but continue doing research.

My wife Lois died from breast cancer on Christmas, 1990. That was a devastating event. Our two children were a constant support during this period. My daughter lives in the Bay area and tutors children with learning and physical disabilities. My son lives in San Diego and is a fireman/crash expert/bio-warfare expert for the Navy. He has two sons, presently 5 and 3 years. His wife also tutors children with learning and physical disabilities in the public school system.

I remarried in 2001 to Sharon Coats, a refugee from Minnesota. We are living for the most part in Las Vegas, Nevada, but commute to Stanford often.

I enjoy solving technical problems and have 8-10 patents, most in optics. I recently became interested in medical issues and have a patent on comparing protein structure that has been licensed by a biotech form to use in the search for new drugs. I have been awarded a National Science Foundation and a Sloan Foundation Fellowship. I am an Overseas Fellow at Churchill College, Cambridge, England and a Professeur Etranger at the University of Paris. My top award is an honorary doctorate from Miami University in 1989.

I am a former Fellow of the American Physical Society, a former Associate Editor of The Physical Review Letters, a former Member of the Physics Advisory Board of the National Science Foundation, and a past chairman of the Advisory Board of the Institute for Theoretical Physics at the University of California at Santa Barbara. As you can see, I get fired a lot.

I have consulted for The Institute for Defense Analysis, the Arms Control and Disarmament Agency, Exxon Production Research, Lightpath Optics, Diamond Microelectronics, and Network Physics Inc. I am one of the founders of Acclivity Photonics Inc, a developer and producer of new fiber optic materials for telecommunications.

I continued playing in jazz groups at Stanford and have even taken some courses in musical composition. A few pieces of mine have been played by local amateur orchestras. The warmest compliment that my music has ever received is 'nonlethal'.

I took up rock climbing while a graduate student at Stanford and have been a member of the American Alpine Club for over 30 years. Some of the new routes that I put up are listed in the Climbers Guide to the High Sierra. At Santa Barbara I was a member of the Los Padres Search and Rescue Team specializing in technical rescues. Some highlights that stand out in my mind are: (1) being struck by lightning immediately upon summiting the Grand Teton via the north face and being unconscious for an hour in 1958 (I no longer glow in the dark), (2) trekking north from Darjeeling, India, towards Everest with Tenzing Norgay (the first to summit Everest) in midwinter 1965, (3) climbing El Capitan in Yosemite Valley (3,000 vertical feet in 2 days) to celebrate my 45th birthday."



## Trinity Alum Pens Suspense Thriller

**BLOODSTONE WILL DEBUT IN JANUARY 2006** 

Nate Kenyon (Trinity, Epsilon Alpha '91) is quickly rising to the top of the horror fiction genre, challenging such authors as Stephen King and Anne Rice for the spooky heavyweight title. His latest book, *Bloodstone*, will be released by Five Star/Thomson Gale in January 2006. *Bloodstone* follows Kenyon's first book, *The Dark Eyes*, in the thriller tradition.

Something about the New England countryside engenders the writing of horror fiction. Nathaniel Hawthorn, Edgar Allen Poe and H.P. Lovecraft preceded our modern-day authors in telling tales of ancient curses and malevolent spirits in the northeastern corner of the nation. Nate Kenyon is carrying on their legacy for new audiences.

A twisted tale of murder and family secrets, *Bloodstone* follows a tormented soul on the run from his past. In the small New England town of White Falls, Billy Smith finds himself amidst a spreading madness of supernatural origin. The reader is carried along on a tale of well-paced terror, that ends with a satisfying bump in the night.

Prior to his intense work in the blood-and-gore literary tradition, Kenyon enjoyed an undergraduate career at Trinity College that included membership in Pi Kappa Alpha. Kenyon recently took time to tell the *Shield & Diamond* about some of his experiences with the Fraternity:

#### Q: How did you come to join Pi Kappa Alpha?

A: "I learned about Pi Kappa Alpha through a friend of mine, who had pledged a semester earlier, and asked me to come to a rush event. Up to that point I'd always thought of fraternities as a waste of time, but when he told me that Pike had a no hazing policy, and talked about all the incredible people he had met,

I decided to see what all the fuss was about. As soon as I arrived at the house, I felt like I was home. I was immediately comfortable. Everyone treated me like an old friend, and it wasn't long before I was an enthusiastic pledge."

"The advantages of becoming a Pike brother were just tremendous. I was instantly accepted; there was always a place for me where I would feel at home, comfortable, at ease, no matter what else I happened to have been going through. I volunteered more often. The decisions I made mattered."

"At the time I pledged, it was a difficult point for me. I had just broken up with a long-time girlfriend back home, and I was sort of floundering around, looking for a place to set my feet. Pike gave me an identity, instant respect among everyone on campus, and a group of lifelong friends. I loved it so much I recruited my roommate the following semester, and he was initiated as well."

# Q: Do you have any interesting anecdotes about the Fraternity?

A: "I remember when the chapter forfeited its university recognition, right after I graduated, it was a very difficult time for both the undergraduate brothers and

the alumni – we were all caught in an impossible situation. The college was requiring all Greek organizations to go coed or disband. Pi Kappa Alpha's Constitution does not allow for coed membership (and the brothers didn't want that anyway), so the solution was for Epsilon Alpha to become an independent (non-university recognized) chapter."

"The brothers had to take

the letters off the house and cease all obvious rush activities. The result was a fairly long period of declining numbers. Through all of this I was very impressed with the dedication of both the undergrad brothers and the alumni who remained involved in the fight. It would have been easy to let the chapter die, but the brothers fought for what they believed in. And today, not only is the chapter thriving, but the Pike flag is on display once again, the chapter is viewed as one of the most respected groups on campus, and the college is reconsidering its position. So that was a real victory."

#### Q: Did you make any friends with whom you've continued to keep in touch? Do you stay in contact with your chapter?

A: "I made lifelong friends by joining Pi Kappa Alpha. I'm still in contact with many of them. There's a great listsery for our chapter



being constructed, and it was there that Robert Lynn hired Jolanda on the spot and Pi Kappa Alpha gave the Penczners their first paycheck and their first good break in their new country.

For the dedication ceremony of the new building in September 1954, the Fraternity wanted large oil portraits of the Founders to grace the walls of "Founders' Hall" in the new Headquarters. The Fraternity looked no further than Jolanda's husband Paul to accomplish this special task. Including the Founders, Paul was commissioned to paint 11 portraits for the Fraternity over the years, the latest being that of Executive Vice President Raymond L. Orians (Memphis, Delta Zeta '66), completed in 1994.

Paul and Jolanda raised three sons in Memphis and have lived nowhere else since they were abruptly abandoned in 1951. The Penczner and Lynn families have remained close. Soon after Dr. Lynn's passing in 1987, the Lynn family gave the Fraternity a portrait of Robert that Paul had done in 1955.

Acquired at an estate sale in the Memphis area last spring, a 1952 Penczner original oil of the Apostle Judas was donated to the Foundation by a local alumnus. Now displaying 13 of his originals, the Memorial Headquarters is home to the largest collection of Penczner originals in the world (outside of Penczner's studio). In addition to the two prints mentioned earlier, the building is also graced with prints of Penczner's pen-and-ink drawings of Jesus Christ and the twelve Apostles, given to the Fraternity upon his initiation in 1994. The originals of Christ and the Apostles are at the Vatican in Rome.

Despite the doubts of his immigration sponsor over 54 years ago, Paul Penczner has become world-renowned for his portrait art, having painted members of many families, corporate executives, politicians, and international dignitaries. Attributed with originating the "oil graphics" method mentioned earlier, Penczner is known for much more than realistic portrait art. He has an expansive amount of work in the surreal and abstract arena. He is also known for creating a painting format called "time expressionism" which involves painting on surfaces that are three-dimensional. round (like a ball), or cylindrical - for the purpose of expressing the continuous characteristic of time, particularly as the work relates to a specific subject. that is pretty active, and so I hear from people pretty regularly through that. And for those whom I haven't heard from in a while, I know that if we were to get back in touch, it would be as if no time passed at all."

"There are some brothers in particular who helped me along the way. Loren Strand (Trinity, Epsilon Alpha '87), in particular, worked so hard with me in my early years as a writer, building an early website, helping design flyers and business cards, and networking. I haven't spoken to Loren in quite a while now, but he was a tremendous influence and source of support for me. I'll always be grateful for what he did."

"The current undergraduate brothers have done a very good job keeping up the communications with alumni. There's a newsletter that comes fairly steadily, and email groups. They are trying very hard to raise money for urgently needed house repairs, and I've pledged a percentage of my royalties from *Bloodstone* to help with that effort. So far I've sent them

a part of my advance, and I hope sales will be strong enough to really make a difference."

"Overall, I think one of the most amazing things about Pi Kappa Alpha is the number of brothers who are willing to jump in and help each other, even years after graduation. It is truly a brotherhood, in every sense of the word. And that is what will make the fraternity continue to thrive—those types of connections, that type of enthusiasm. Everyone needs a place to feel at home while in college, and for me, Pike was it. I've never regretted that decision, and I would enthusiastically recommend it to anyone."

Nate Kenyon's fiction has been called "terrifying," "riveting," "masterful" and "genuinely scary". His work has appeared in various magazines and in the horror anthology *Terminal Frights*, and he is a member of the Horror Writers Association. Kenyon lives in the Boston area with his wife, Nicole, and their three children. In addition to his working as an author, Kenyon is employed as director of marketing communications with Boston College Law School.

ACROSS THE YEARS, PIKES HELP EACH OTHER FIND WHAT'S IMPORTANT IN LIFE.



January 30, 1975. April 5, 1980. Two dates that are the cornerstone for teaching me the meaning of this Fraternity. The purpose of this letter is to share a very personal story of the men – brothers – who have been icons in my life.

My story actually begins in 1935 with the initiation of L.A."Brooks" McCall (Presbyterian, Mu '32). While in school, he served his chapter as treasurer, vice president and president. At the National Convention in 1946 at Mackinac Island, Brooks was instrumental in speaking for a Memorial Headquarters and a centralized organizational structure. Brooks believed in the sacred ideal of honoring those who had given their lives defending our country. He saw the establishment of a new headquarters as an opportunity to designate the building as a memorial to those brothers who sacrificed their lives for our country and freedom.

Brooks was a national vice president in the 1950's. Later, and through his efforts and support, a new chapter of Pi Kappa Alpha was established at Francis Marion College on May 19, 1974. Eight months later, on January 30, 1975, I was initiated into the Fraternity. The ceremony was conducted at the home of Brooks McCall. In 1986, Brooks was honored for over 50 years of service to our Fraternity when he was inducted into the Pi Kappa Alpha Educational Foundation's Order of West Range.

Now, turning to the fall of 1978 at Winthrop College. I decided to wear my jersey with the Greek letters "ITKA" to class just as I had done as an undergraduate at Francis Marion College. As I was walking down the hall very early in the new semester, innocently minding my own business and looking for the room, I suddenly felt the strong slap of a hand on my shoulder. That was a surprise but it was more of a shock when I turned and saw a member of the faculty standing there with a very stern look on his face.

He did not introduce himself but gruffly ordered me to come to his office for what was clearly going to be a serious discussion. Reaching his office, he closed the door and asked why I was wearing that jersey. When I explained, Dr. Joseph E. Krebs (Miami, Gamma Omega '55) suddenly smiled and said that he was thrilled to have another Pike on campus!

Dr. Krebs had been actively working with the Pi Kappa Alpha National Headquarters staff for at least the three previous years to establish a new chapter. In fact, only one year earlier a group of men had been evaluated as a potential colony, but it was ultimately determined that this group did not meet the standards and ideals

necessary to become a chapter of Pi Kappa Alpha.

Earlier in his career, Dr. Krebs had been instrumental in establishing Eta Sigma chapter at West Georgia College in 1972. He was personally committed to building on our beloved Fraternity's tradition of excellence. Following my first meeting with Dr. Krebs in 1978, and as a direct result of his support, determination and leadership, the Theta Sigma chapter would be installed on April 5, 1980.

This letter has been a "work in progress" for thirty years, and here are a few personal highlights:

- My initiation certificate was signed by National President Jerome V. Reel, Jr. (Tulane, Eta '57). Dr. Reel would later personally autograph my copy of "The Oak" after speaking at a Theta Sigma banquet.
- As a chapter consultant, D. Mark Anderson (Wofford, Nu '76), now past international president, provided constant support and guidance for Theta Sigma.
- As director of housing, Ray Orians (Memphis, Delta Zeta '66), now PiKA's executive vice president, offered experience and counsel as Theta Sigma became the first Greek organization at Winthrop to have their own house.
- · When my father suffered a major heart attack, three PiKA brothers proved invaluable in helping me and my family deal with the emergency. Terry Williams (Francis Marion, Theta Delta '74) opened his home to my mother for many weeks when my father was in the hospital. Billy Fields (Francis Marion, Theta Delta '75) sacrificed time with his own family in order to make sure that my family had transportation to the hospital. And R. J. Reynolds (Francis Marion, Theta Delta '74) used his experience and resources to help my mother deal with the home security issues of living alone after my father died.
- · Several years later, when in the midst

of a different kind of personal crisis, John Fitz (Francis Marion, Theta Delta '78) and Mike Newton (Francis Marion, Theta Delta '77) unexpectedly drove over two hours to meet me at an airport when they knew that I would arrive there feeling alone and without hope. They were determined to show me that brotherhood did not stop even when separated by time and significant distances.

• Bill Berry (Winthrop, Theta Sigma '81) is the model of what a chapter advisor should be and Phil Murdock (Winthrop, Theta Sigma '92) has provided significant leadership for the housing corporation. They have dedicated their time and energy in so many ways; their contribution to the success of Theta Sigma is virtually incalculable.

Now you have met the men who have become my personal icons: Brooks McCall; Joe Krebs; Terry Williams; R. J. Reynolds; Billy Fields; John Fitz; Mike Newton; Jerome V. Reel, Jr.; Raymond Orians; D. Mark Anderson; Phil Murdock; Bill Berry. They are Pi Kappa Alpha. Where are you in your own personal journey? Where is Pi Kappa Alpha in your life today?

Many of you have similar stories. Pi Kappa Alpha is not limited to our years as undergraduates. Our life's experiences are enriched because of the strength of our brotherhood. I want to challenge you to get – and stay – involved.

For Pi Kappa Alpha, and indeed for us as individuals, we cannot afford to approach life as a victim. We are all in this Fraternity because at some point in our lives, someone – like a Brooks McCall, a Joe Krebs, a Terry Williams or R. J. Reynolds or Bill Berry or Phil Murdock – someone thought we had something to offer. Now is the time to demonstrate our commitment to those same sacred ideals that inspired our Founding Fathers in 1868. Together, we have the potential to enable the Fraternity to meet its goals and fulfill our vision of excellence.

Two dates: January 30, 1975 and April 5, 1980. Thirty years ago, I was initiated into a lifetime of being Pi Kappa Alpha. Twenty-five years ago, the Theta Sigma chapter started its journey to excellence ... and it is only the beginning!

# Jason J. Collier (Indiana, Delta Xi '97)

Jason J.
Collier entered
Chapter Eternal
on October
15, 2005. A
professional
basketball player
who spent the
last two years
playing power
forward and
center for the
Atlanta Hawks,



Collier died of a sudden heart rhythm disturbance caused by an abnormally enlarged heart, an autopsy showed. He was 28.

At Central Catholic High School in Springfield, Ohio, Collier was named "Mister Basketball Ohio." He played college-level basketball at Indiana before transferring to the Georgia Institute of Technology. His father, Jeff Collier, played at Georgia Tech from 1972 to 1976, and Jason initially wore No. 52 in his honor.

In 2000, the 7-foot, 260-pound center was drafted by the Milwaukee Bucks in the first round. He was traded to the Houston Rockets, where he played backup for three years, then signed as a free agent with the Minnesota Timberwolves in 2003.

Collier joined the Atlanta Hawks in 2004, and started 44 games – averaging 5.7 points and 2.6 rebounds in 13.5 minutes. He scored a career-high 22 points against Washington last season and pulled down 11 rebounds against Toronto. Although he was not projected to start this season, Collier passed his preseason physical and was considered a top backup. In two preseason games, he averaged 3.5 points and 3 rebounds.

He is survived by his wife, Katie, his two-year-old daughter, Ella.

#### H. Neal Jones (Illinois, Beta Eta '32)

H. Neal Jones entered Chapter Eternal on July 12, 2005, in Denver, Colorado. He served in the Navy in the Pacific during World War II, and spent his career with the Nothwestern Mutual Life Insurance Company. In 1972, he moved to Sun City, Arizona, where he was an active golfer and volunteer until 2004, when he moved to Denver to be near his two surviving daughters, Judith Gors and Jaren Ducker. He was preceded in death by his wife, Vera Cook Jones.

# Thomas E. Spragens (Kentucky, Omega '52)

Thomas Eugene Spragens entered Chapter Eternal on August 4, 2005, doing what he enjoyed most. He was with a group of friends playing golf in Lexington, Kentucky. Gene came to the University of



Kentucky in 1952 with Pi Kappa Alpha decals already on his car windows. He pledged his freshman year and served as both treasurer and president. He was a member of both the UK marching band and the concert band and continued to return to the campus one game every year to play in the alumni band as well as in the pep band at basketball games during the semester break. Gene also graduated from the Louisiana State University Graduate School of Banking of the South, where he later served on the board of trustees. He returned to his home of Lebanon. Kentucky and went to work at the Farmers National Bank, a family owned bank, working his way from cashier to vice president and eventually succeeded his father as president. In addition to his banking duties, Gene served on the Lebanon City Council for ten years, served as the mayor of Lebanon for one term, was a member of the Lebanon-Marion County Chamber of Commerce and served as its president, was the founding president of the Marion County Industrial Foundation, was both secretary and president of the Marion County Rotary Club, served on the board of directors of the Kentucky Mountain Laurel Festival and also as its president, was a director of the Thomas D. Clark Foundation, was chairman of the Lincoln Trail Area Development board of directors, and served as the treasurer of the United Way of Kentucky board of directors. Gene was also president of the Kentucky Bankers Association and a
