## All I Need To Know About Business...

Many years ago I read a book called All I Need to Know I Learned in Kindergarten by Robert Fulghum. It was short book that was popular around 1990; an easy read that could be completed in one, maybe two legs of a business trip. It was full of pithy life lessons that were simple to understand but

perhaps not so simple to practice. The essence of the book is betrayed by the title: most of the important, foundational life lessons are learned at a young age.

I am always thinking about writing a business book. I have several titles already determined, but I just don't have enough material yet to fill enough pages to make it a respectable length. There is one idea I've been thinking about lately that I do have plenty of material on, especially since it wouldn't need to be very long to get the message across. Its title is All I Need to Know about Business Management I Learned at Pike.

Now I am not trying to suggest that all the time and money spent on business school were wasted or that I have not learned anything along the way. Quite the contrary, I received tremendous benefit from business school and am constantly learning on the job – continual learning is one of the things I like most about business. What I believe is that business school was more relevant and meaningful because of the Pike laboratory, and that as I learn new things about business management on the job, I can often tie them back to something foundational I learned in the chapter.

Allow me to elaborate. I ask if you have found the same to be true for you.

For starters, I can't think of anything significant I have accomplished in my still short business life that wasn't achieved through working in cooperation with others. Learning to accomplish goals and objectives by working with others is one of the first and perhaps most important lessons taught in the chapter. It starts the day you sign the pledge card and continues right on through to graduation.

I recall during my pledge semester my chapter volunteered to help during a parade through our local downtown. Our job was to carry the large helium filled Disney character balloons. There were eight balloons and it took an average of five people to hold each one down to prevent it from floating away. I was what most in business would refer to as an "individual contributor". I was there to perform my part, one of five holding on to the Dumbo balloon, one of 40+ members working on the project overall. Together we achieved the task – finish the parade without letting the balloons float away while making sure to pull

them low enough to cross under traffic lights at the intersections.

I was next given a chance to be the public relations chairman. At the time, our chapter did not assign a committee for this area. Of course I still had to get things done through others. I just had to find ways to motivate other chapter members to help me with the initiatives I had planned. Who in business has not found themselves in this situation at some point in their career: a project to deliver or an objective to meet that requires the work and support of others who do not report to you? I was not a fan of this "no committee" approach at the time, but looking back I realize that I got some early practice in leading an activity without any team to direct.

This chairmanship also gave me the opportunity to manage a budget for the first time. At the age of 18, I was responsible for the appropriation of \$2,000 on behalf of the chapter. It doesn't seem like a lot of money today, but at the time it was the first fiduciary responsibility I had to any organization. Just like in business I had to regularly report the results of the activities for my area of responsibility to upper management (the chapter vice president), including progress toward objectives, budget status, and next steps.

Eventually I was fortunate enough to be elected chapter president and got a chance to try my hand at executive management. The opportunity to be part of an executive management team responsible for setting strategic direction, organizing resources, motivating key personnel, and overseeing an operation in excess of \$100,000 does not come to many at the age of 21. The importance of collecting receivables, managing cash flow, and cutting expenses when necessary are stresses I did not relish, but I clearly gained some early insights into the harsh economic realities of keeping a business running.

Arguably one of the most difficult tasks of an executive management team is to align and motivate all the resources in the organization, from the executive suite to the front line. This often becomes more and more difficult the further you get from the executive team. Usually, those closest to the executives are in alignment; however, as you get further out to the edges, it becomes more and more difficult to align activities. There have been many books written about how to achieve this alignment and many have come up with simple ways to get the front line insight. Any novice student of business knows of Sam Walton's philosophy of Management By Walking Around, whereby he would walk the Wal-Mart stores and talk to the front line to learn of their challenges and

## 2007 House of the Year Award recognizes one of Pi Kappa Alpha's jewels

Alpha Kappa Chapter at the University of Missouri, Rolla was the recipient of the 2007 House of the Year Award at The Academy in summer 2007. The current chapter house in Rolla, Missouri was completed in 2001, following a fire that burned the old house to the ground. An addition to the house was finished this summer.

The tragic fire in 1999 that destroyed Alpha Kappa's old house also took the life of Brother Jared Adams '97. The house corporation then vowed to rebuild one of the safest and most structurally sound fraternity properties in North America. The Pike house, constructed almost entirely of concrete and steel, with metal framing, stands as a fortress in Rolla. It also includes state of the art fire detection and sprinkling systems.

The house in Rolla is English Tudor style, with a front façade that looks nearly identical to their previous structure, preserving the brand of that facility which was well established over its 70-year history. The address remains the same at 613 W. 9th Street, but the building itself is

far more grand. The house, including its recent addition, is over 28,000 square feet and can accommodate 104 men.

As you enter the front door to this amazing building, you will immediately notice a tile mosaic of the Fraternity's coat-of-arms, a beautiful piece donated by an alumnus of Alpha Kappa Chapter. Traveling into the formal living room, you will see a fireplace which includes a limestone mantle, maintained and preserved from the previous house. There is also a donated antique grandfather clock built in 1874, when Pi Kappa Alpha was a mere six years old.

The inside of the house includes almost as much common area as it does living space. Between the library, formal room, recreation room and computer room, brothers always have plenty of space to accommodate guests and host events. The common areas are not the only state of the art amenities; bedrooms include built-in lofts with desks underneath to maximize free space within each living quarter. The addition, which was designed to house upperclassmen, provides a more private living environment with "suite" style bedrooms.

#### Good Management is the Key to Success

Alpha Kappa has its own house management manual. The introduction states that it was created to "ensure

that future Brothers of the Alpha Kappa Chapter in Rolla, Missouri would have a beautiful, comfortable, and safe building to call home". The information contained within that manual is designed to do exactly that. It is one of the most comprehensive management guides ever seen and serves as a model for all chapters to emulate.

- The chapter leases the house from the house corporation on a flat annual rate, meaning it does not fluctuate with occupancy, and then subleases to the individual tenants.
- One-year written agreements are used, with rent to the house corporation and individual room rents being due twice a year, prior to the start of each semester.
- The chapter charges a market rental rate that is competitive with oncampus residence hall living. In doing

- so, the chapter and house corporation are able to properly maintain their house and build reserves for the
- The chapter also enforces by-laws, policies and house rules pertaining to the treatment of the facility. There are documented procedures for filling out damage and repair reports.
- The chapter requires a significant security deposit from all tenants.
- By-laws stipulate a live-in requirement for eight semesters in order to maintain full occupancy of the property.

Alpha Kappa's manual also includes a detailed outline of house corporation operations, chapter management responsibilities, detailed house upkeep procedures, house rules, and all chapter by-laws related to housing. Roles and responsibilities for the chapter house manager, assistant house manager, and kitchen steward are clearly stated in the manual as well.

The chapter house manager is appointed and responsible for supervising the kitchen steward, administering a comprehensive seasonal maintenance program, managing a housing committee, assigning daily and weekly cleaning duties to all members, and conducting periodic room inspections to ensure safe living conditions. There is a strict no-smoking policy enforced and absolutely zero tolerance for destruction of house property, with strict fines in place.

The Chapter and House Corporation are to be commended for their beautiful home and are well deserving of the 2007 Pi Kappa Alpha House of the Year.

## Epsilon Alpha Chapter Takes Improvement Project of the Year Honor

Epsilon Alpha Chapter at Trinity College brought home the award for Best Improvement Project of the Year, presented at The Academy in Memphis. The chapter house is located at 94 Vernon Street in Hartford, Connecticut. The original structure was built in 1880, and since then many renovations and updates have been made in order to maintain the house.

The award winning project completed by Epsilon Alpha was a total renovation of the main bathroom. To start, the linoleum floor was replaced with durable tile. The chapter replaced three stand-alone sinks with drop-ins into a new expanded counter space. The sink area was finished with new fixtures and a tile backsplash, as well as a new large mirror. Two old toilets were replaced and the chapter swapped the old wooden stalls for ones made of durable metal. The chapter also replaced three shower stalls and upgraded all of their fixtures. The bathroom project was completed with a fresh coat of paint. The project took three weeks to complete and cost the housing corporation roughly \$56,000.

The success of this project is the result of a very dedicated house corporation. They have identified several projects that need to be completed in order to make their house the most competitive on campus. The corporation is currently overseeing the renovation and repair of the house's foundation. In the future,



they also plan to replace all of the windows, widen the staircase, renovate the kitchen and raise the roof.

#### Delta Pi (San Jose State) Pikes Run For Pat Tillman Foundation

Pat Tillman graduated Summa Cum Laude from Arizona State University in 1998, and went on to win the Pac 10 Defensive Player of the Year as a linebacker. The Arizona Cardinals drafted him in the 7th round that following year. Even though many people questioned his ability to make the opening-day roster, he soon became the team's starting safety and broke the franchise record for tackles in 2000 with 224. In 2002, he turned down a multi-million dollar contract to serve his country in an elite Army Ranger Unit and died in 2004 while serving his country in Eastern Afghanistan.

After his death, the Pat Tillman Foundation was born and raises money to assist in developing tomorrow's leaders today. April 29, 2007 marked the 2nd Annual Pat's Run held at Leland High School in San Jose, California.

Approximately 6,000 people attended this year's event with the Delta Pi Pikes showing up in force. The Pikes were responsible for the 1st mile marker of the 4.2 mile race and had a banner spanning across the street for all to see. Kurt Carrasquilla '89 and Jad Mogannam '04 coordinated this year's Pi Kappa Alpha volunteering effort. They had 30 brothers supporting the 1st mile marker and 11 runners including some alumni.

John Van Metre '01 was the top finishing Pike covering the 4.2 mile course in 27:21 minutes. An impressive note was that after Stan Vuchovich '82 finished the race he went on to score three goals that afternoon for the competitive men's soccer team he plays on.

Alex Garwood, Executive Director of the Pat Tillman Foundation, greatly appreciated the Pikes getting behind the race as well as the Foundation.

Pi Kappa Alpha's strongest chapters, as exhibited by the Fraternity's perennial Smythe and Excellence Award winners, have instilled a culture of financial responsibility within their membership. Beginning with new member education, financial responsibilities are clearly explained, and the consequences for failing to live up to these expectations are established. As a result, these chapters enjoy a steady cash flow and full social calendar, as they are able to budget and manage their funds throughout the academic year.

The key to creating this financial culture is communication. The chapter finance committee communicates with the membership on a regular basis, explaining how money is budgeted, and which members have upheld their financial obligations. As a result, the chapter's membership can clearly see the results of what happens when members do not pay on time. As a non-profit organization, a chapter does not have the reserves needed to operate without income. In other words, no payments: no programming.

There are a number of resources on the Fraternity's website at www.pikes.org that are designed to help chapters establish this culture of financial responsibility. Additionally, the Fraternity's staff is always ready and willing to assist chapters in any way possible. New resources are constantly being developed, including a standard chapter operating budget and a new online chapter dashboard (http://dashboard.pikes.org) where chapters may view and pay their balance to the International Fraternity.

Over the past year, Pi Kappa Alpha's chapters have renewed their attention to chapter finances. As a result, the Fraternity continues to grow and increase in its financial stability, and overall, chapters are able to successfully maintain their financial responsibilities to the International Fraternity.





Delta Chi (Nebraska-Omaha)
Active chapter size: 61; fall pledges: 48. The chapter sent five men to the 2007 Academy and forty-one men to the Kansas City Leadership Summit. The chapter began a new member personal development program with core ideas taken from Pike University. 



#### PIKEtoberfest – One Small Chapter's Attempt To Create The Biggest Campus Event



#### Kappa Delta (Northeastern)

Active chapter size: 50; fall pledges: 21. The chapter sent two men to the 2007 Academy and ten men to the Philadelphia Leadership Summit. The chapter also hosted an event called Piketoberfest:

"Piketoberfest was initially an idea spawned from nothing more than a sample t-shirt created by a Greek clothing website. We jokingly began talking about how great it would be to put on an event mimicking Germany's Oktoberfest, which, ironically, takes place in September. We were hesitant, however, in knowing that fraternities have not been taken seriously on NU's campus thus far, and also in realizing that we would need a significant amount of money to make this event unforgettable. Despite all of this, we came to the conclusion that a Greek organization is capable of such a task, and that Pi Kappa Alpha would be the Fraternity to prove it. Our dreams and thoughts eventually turned into ideas, and ideas turned into motions set towards one supreme goal: to put on one of the biggest campus-wide events in Northeastern history to be enjoyed by ALL Northeastern students. Soon, we formed a committee, equipped with subgroups in charge of certain aspects of the event, and we were well on our way.

After a month of preparation, we were ready to appeal to our campus' Budget Review Committee, which is a group in charge of allocating over \$1.5 million to student groups interested in programming campus events. We were able to construct a budget that was approved, and a few weeks later \$75,000 was deposited into our account. With that money, our committee began working on what would become hundreds of hours of negotiating





contracts with bands, getting city permits, meeting with our administration, and much more, to be able to finally hang a 30-foot banner over our campus' main street. There, in huge letters hung a huge banner, announcing PIKEtoberfest, a free concert featuring the bands, giveaways, free food, student group tables and other various activities.

On September 22nd, the big day, our entire chapter woke up at 6:00 a.m. to set up a 46-foot stage. Through delegation and coordination we were able to set up the stage, fire up the barbeque, blow up the inflatables, and organize the other student groups' tables. By the mid-day, we had 3,000 students from all over Boston in our quad watching a concert with our four-foot-tall letters gleaming in the sun on the top of the huge stage. We passed out PIKEtoberfest t-shirts and ping-pong balls, we mingled with potential rushees, staffed the event and assisted with community, and a few of us went on stage to introduce the bands. We all stayed until 10:00 that evening exhaustedly taking down the stage with smiles on our faces: we knew we had just changed the entire Greek System at Northeastern forever by stepping it up to this level.

The next week, we made the front page of our school's newspaper. We became the talk of the entire school. Even the administration was so impressed with our organizational skills that they are asking when we would be planning our second annual PIKEtoberfest. That week was also our rush week, and, like we had hoped, we received over 100 men interested in PIKE. We remained selective and we can now proudly say that we currently have the biggest pledge class in our chapter's history, consisting of 23 great young men."

#### Minnesota Colony Member Finds Innovative Way To Help Red Cross

The I-35W Mississippi River bridge was an eight-lane, 1,907-foot steel truss arch bridge that carried Interstate 35W across the Mississippi River in Minneapolis, Minnesota. The bridge carried 140,000 vehicles daily. On Wednesday, August 1, 2007, during the evening rush hour, the main spans of the bridge collapsed, falling into the river and onto its banks. Thirteen people died and approximately one hundred more were injured.

In the wake of those tragic events, a
Minnesota colony member is out to make a
difference. Pianist Philip Thompson, founding
colony president, has set an impressive goal
of raising \$1,000,000 for the American Red
Cross with his musical composition, "Final
Ride Home."

Two days after the bridge collapse,
Thompson made a trip toward the Mississippi
River to view the scene, and that evening set
about to transform his raw emotions into a
poignant instrumental. Less than two hours
later, the acclaimed pianist had composed
"Final Ride Home," a compelling tribute to
the victims of the tragedy, their families,
and volunteers – especially from the Red
Cross – who offered their assistance after the
disaster.

Thompson recorded the piece the following day and quickly made it accessible to the public where it can be downloaded for 99 cents through iTunes and CD Baby with 100 percent of the proceeds benefiting

the local Twin Cities Red Cross chapter operations.

The American Red Cross Twin Cities Area Chapter is a humanitarian organization led by volunteers, providing

relief to victims of disasters and helping people prevent, prepare for, and respond to emergencies. The American Red Cross is not a government agency; their programs rely on financial support and voluntary service from generous citizens in the Twin Cities area.

In the first week of the relief efforts, Red Cross mental health staff and nurses comforted more than 700 people dealing with grief, trauma and medical conditions. They also provided emotional support for an additional 1,288 people who expressed concern about missing loved ones. More than 560 Red Cross staff members and volunteers have given their time to help those affected by this tragedy.

The gentlemen of the Minnesota colony ask for your support in an effort to raise money for this event and to bring awareness to the heroic efforts of the Red Cross.

In fall 2007, Pi Kappa Alpha launched its expansion efforts at Sam Houston State University with the objective of recruiting the most, best men to build the foundation of Pike's triumphant return to campus. With the completion of the project, Pike's presence immediately impacted campus. The colony is Sam Houston's largest active group, and has set a new standard for academic success and gentlemanly conduct. The Supreme Council is proud to recognize the new colony at Sam Houston State University.

Epsilon Pi Chapter was chartered at Sam Houston State in 1961. Over the next 30 years the chapter built a reputation of competitiveness and high character while establishing itself as a dominate fraternal organization. Sadly, Epsilon Pi Chapter closed its doors in 1992 after financial troubles. However, the bonds formed throughout the many years have continued to

keep the memories and traditions of Epsilon Pi Chapter alive.

After nearly a 15-year absence, and with incredible alumni support and the highest quality undergraduates, a colony has been formed on the Huntsville, Texas campus.

Consultants James Card (Nebraska-Omaha, Delta Chi '03) and Benjamin Barone (Vermont, Lambda Delta '04) spent four weeks in Huntsville conducting the referral-based expansion project. Sam Houston State sorority women, athletic coaches, organization presidents, and university administrators provided the consultants with insight and recommendations for candidates who best exemplify the qualities of Pi Kappa Alpha.

The consultants generated over 200 names and conducted nearly 150 interviews to determine who would be invited to serve as the founding fathers of the colony. After only four weeks, the colony has 67 impressive gentlemen.

The colony is distinguished by its athletic achievements, with nearly 100% of its members involved in intramural, club and varsity sports.

The colony boasts members from the varsity football team, varsity track and field, and members from the #5 nationally ranked power lifting team. The club teams represented are rugby, soccer, baseball, paintball and combative martial arts.

Additionally, the group represents a broad scope of campus organizations and volunteer programs within the Huntsville community: Christian Youth Groups, Boys and Girls Club, U.S. Army, Special Olympics, Habitat for Humanity, Alpha Kappa Psi Buisness Fraternity, Student Government, Lead America, Diversity Leadership Council, NAACP, and Program Council

Serving as colony advisor is Nik Thomas (Epsilon Pi '85). Thomas has called upon six Epsilon Pi initiates to serve in various positions on the advisory board: Stephen Collete '87, Cliff Brayshaw '85, Kurt Kittler '87, Harry Miller '83, Jared Jensen '87 and Kurt Granhold '84.

## Chicago Law

#### Federal Prosecutor T. Markus Funk Takes On Crime In The Windy City

Interview by Michael Hoadley (Illinois, Beta Eta '88)

Pi Kappa Alpha has a rich tradition with the City of Chicago, and the subject of this profile, T. Markus Funk, while contributing to that tradition, has at least one potential role model in his chosen line of work as a Federal Prosecutor, Technically known as an Assistant United States Attorney, Funk follows in the footsteps of another Beta Eta legend, Samuel L. Skinner '57 (known among the prosecutorial community affectionately as "Sam The Hammer"), who was appointed by President Gerald Ford to lead that office in 1975, and would later go on to serve as U.S. Secretary of Transportation and White House Chief of Staff under President George H.W. Bush.

Just about the same time as Skinner was going on to serve in President Bush's cabinet, Funk's grandfather would bring his grandson along on visits to Champaign. Funk recalls visiting the Department of Agriculture and walking on the Quad with his grandfather as he met with University officials in connection with the family's hybrid seed corn business. The Funk family in fact has a long history in Illinois, building the first meat-packing house in Chicago and co-founding Chicago's Union Stockyards and Illinois Wesleyan University. Funk's great great grandfather, LaFayette Funk, was the Superintendent of the 1893 Chicago World's Fair and worked with Abraham Lincoln to bring the Chicago Alton Railroad to Bloomington, sidetracking it from its planned route through Peoria. The family was also influential in agriculture in McLean County, establishing the first method for growing hybrid corn that spread worldwide. Chances are, if you've had a cheeseburger or steak recently, the corn used to feed that cow contained a strain of hybrid corn developed by Funk Brothers Seed Company. T. Markus Funk was raised primarily in Germany, attending Frankfurt International School, where he graduated as the valedictorian and senior class president.

When asked how Pi Kappa Alpha helped to prepare him for later life, he recalls, "I was new to living in America

full time, and the Fraternity encouraged me to become friends with some people with whom I might not have otherwise spent as much time." This, and daily life among his Fraternity brothers, provided growth experiences for Funk.

He graduated from Illinois in 1991 with two degrees, a bachelor of arts in linguistics and a bachelor of science in business; spent a season in Steamboat Springs, Colorado as a night clerk at the local Super 8 Motel, and as a ski technician at the Sports Stalker in Gondola Square, before starting law school in Chicago in 1992.

After graduating from Northwestern Law School in May 1995, Funk went to St. Louis to work for federal District Court Judge Catherine Perry as a law clerk.

As if two bachelor's degrees from Illinois and a Northwestern University law degree were not enough, Funk sought a Ph.D. in law at one of the world's most prestigious institutions of higher learning. He spent 1997-1999 at New College at Oxford, while at the same time teaching criminal law as a Lecturer in Law.

Returning to the U.S. for a summer at his grandfather's ranch in the Rockies (his favorite place in the world, where he still goes from time to time with Fraternity brothers and other friends), he accepted a one year position in Arkansas with the 8th Circuit Court of Appeals and

Judge Morris Arnold, one of nine judges responsible for much of the nation's midsection.

Funk's role with the U.S. Attorney's office began in 2000. There, he worked in the General Crimes division through 2002, followed by work in the International Drug Cartel division through 2005.

Detailed to the U.S. State
Department through April 2006 as
resident legal advisor in the U.S.
Office in post-conflict Pristina,
Kosovo, he advised the Chief of the
United States Mission on various
legal matters. He also assisted local
and United Nations prosecutors,
judges, and law enforcement
personnel with training, advice and
material support. In recognition
of his hard work and dedication,
Funk became the only non-State
Department official to be awarded

the U.S. State Department's "Superior Honor Award," and the first person to earn the award in their first year of service with the State Department.

#### What was it like in Kosovo?

"After the 1999 NATO bombings in Kosovo, there were multiple layers of governance: UN, national and local. This made getting up to speed a real challenge, because it was often unclear who was authorized to do what.

The unrest in the area followed centuries of antipathy between the Christian Orthodox Serbs and the largely Muslim Albanians. The median age of the Kosovo inhabitants is 22, with a 60% unemployment rate. The basic justice system was in transition from an inquisitorial system to an adversarial system, which is more decentralized and places more responsibility on the attorneys, particularly on the prosecutors. All these factors made the work there very challenging.

What made work and life in Kosoyo much easier was that the Muslims in Kosoyo had an extremely positive attitude towards the United States. President Bill Clinton pushed the United Nations to unseat Serbian strongman Slobodan Milošević, and so the main street in Kosoyo is Bill Clinton Avenue,

which crosses Bob Dole Street (Sen. Dole was the first member of Congress to visit Kosovo)."

## What do you think about U.S. foreign policy and the era we are living in, given your experience?

"There can be no question that our continued involvement in foreign affairs, particularly on the ground promoting good will in places where democracy and the rule of law has not yet fully taken root, along with our involvement in training local lawyers, nurtures long-term friends, because we persuade people of the justice and democratic nature of our legal system.

Kosovo, after all, is a back door to Europe – training judges and prosecutors there and instilling the values we share will create strong allies on down the road. Democracy building, grass roots diplomacy and encouraging adherence to the rule of law is where the rubber meets the road. If you can instill in people a sense of justice and a sense of civic responsibility, then everything flows from that."

Another inspiration for T. Markus Funk may be Everett M. Dirksen (Bradley, Delta Sigma '60), the namesake of one of the Federal complex of buildings which houses the U.S. Attorney's offices, the Federal Courts, U.S. Marshals, Immigration, and other Federal agencies. These buildings in the heart of Chicago's Loop are where protests, demonstrations, and other human dramas such as the recent "Operation Family Secrets" trial play out daily. This is the scene where Funk, "On Behalf of The People of The United States," has helped put a raft of bad guys in jail, including child pornographers, international drug cartel figures, and pedophiles. And it was here that he and his colleagues recently put an end to the criminal careers of 12 members of the "Chicago Outfit" (see sidebar).

When Funk decided to return to Chicago from Kosovo, one of the major contributing factors was the opportunity to work on the "Family Secrets" team.

## Can you contrast the Chicago mob and organized crime in Kosovo?

"Both run along familial lines, though in Chicago there is a level of understanding that business is paramount, and murder, particularly of witnesses, prosecutors and law enforcement, is not 'good for business.'

In Kosovo, the system is much less mature, and witness protection is virtually non-existent. The investigative or law enforcement system provides little Chicago is still known in many parts of the world as a gangster city, home of Al Capone and Elliott Ness. The Chicago Sun-Times recently described Funk's role in the "Family Secrets" prosecution as follows:

## FAMILY SECRETS Prosecutor slams Calabrese Sr. alibis

A federal jury on Monday heard Frank Calabrese Sr.'s Greatest Hits as a federal prosecutor played tape after tape of Calabrese Sr.'s own secretly recorded voice describing in detail mob hits he allegedly committed.

It was the young blonde prosecutor vs. the aging, balding reputed hit man as Assistant U.S. Attorney Markus Funk tried to shred Calabrese Sr.'s alibis and underscore Calabrese Sr.'s true nature as Funk gave the prosecution's closing argument in the case.

"You can hear that man laughing, laughing about the murders," Funk said, pointing to Calabrese Sr., as he referred to one secretly recorded conversation involving Calabrese Sr. and his son Frank Jr.

"There's nothing funny about that, is there?" Funk said, staring down at Calabrese Sr.

"Are you asking us?" Calabrese Sr.'s attorney, Joseph R. Lopez, shot back.

Calabrese Sr. would at times shake his head and smile during Funk's closing argument.

Calabrese Sr. took the witness stand earlier in the trial and tried to explain away his words as nothing more than a father trying to impress his son. The two were both in prison in Milan,

Mich., after they pleaded guilty involving the loan sharking crew Calabrese Sr. ran.

Calabrese Sr. worried he was losing his son's loyalty to Calabrese Sr.'s brother, Nicholas, who has admitted killing at least 14 people.

Funk slammed Calabrese Sr.'s explanation. "It was not laughable," Funk said. "It was outrageous."

Funk laid together one piece of evidence after another to show the case prosecutors have made during the 10 weeks of trial against Calabrese Sr. and the other defendants in the Family Secrets trial: reputed top mobsters Joseph "Joey the Clown" Lombardo and James "Little Jimmy" Marcello; the Outfit's reputed man in Phoenix, Paul Schiro; and alleged crooked Chicago cop Anthony "Twan" Doyle.

If Funk's closing argument dwelled most on Calabrese Sr., it might be because he is accused of the most murders – 13 in all.

And no other defendant was recorded at length discussing Outfit murders in depth. Calabrese Sr. was recorded by his son, Frank Jr., who also testified at trial against his father.

Funk questioned why Calabrese Sr. is heard to be so concerned on the recordings about whether his brother, Nicholas Calabrese, is cooperating with law enforcement if Nicholas Calabrese has nothing valuable to say.

And he questioned why Calabrese Sr. would discuss on another recording setting up an alibi for one murder if he had nothing to hide.

"Frank Calabrese Sr., the man with a smile," Funk said, his voice booming.

"The man with a smile. There's nothing to smile about in this case."

deterrence, so therefore, not much risk of 'business' interruption exists from killing witnesses, prosecutors or anyone else who happens to 'get in the way' of the criminal enterprise."

#### Given popular cultural depictions of the American mob (e.g., The Sopranos), would you think there are some lines they wouldn't cross?

"There may be lines that generally go uncrossed, but not for benificent reasons. For example, the odd popular fiction that the mob doesn't kill women is certainly belied in this case by the murder of Charlotte Dauber, wife of mob enforcer Billy Dauber, who was killed along with her while driving down a country road.

Greed breeds the ruthlessness. The Chicago mob's primary money makers continue to be street tax and gambling. The mob endeavors to stay very far away from anything federal law enforcement is particularly interested in, such as drugs.

Mob Boss Anthony Accardo, who died in 1992, in fact had a form of an injunction against getting involved with narcotics for fear of drawing the attention of the FRI."

#### Can you talk a little about what drives you to do something that many feel might be a risk to their own or their loved ones' safety?

"You have to be cautious, but anyone who decides to take on this job while having an undue concern about his or her safety will not be effective. Harm to prosecutors or law enforcement is exceedingly rare, and for good reason. Consider this: anyone in organized crime would find themselves scrutinized to a level they couldn't even imagine before, and if someone in the mob went ahead with such a violation of the 'chain of command' they would be internally

disciplined. The family members of the murdered expect you to represent their interests, and that is a heavy responsibility. There is a great sense of personal and professional satisfaction from delivering them a sense that justice was served. The focus therefore is on vindicating their rights and interests, not on the unlikely event of mob retribution."

## Why do you do what you do, and what do you think you have given up?

"There is a sense of personal satisfaction in putting a business deal together in private practice, but there's no question that satisfaction, at least for me personally, can't compare to something like the 'Family Secrets' convictions. Public service as a prosecutor is a way of serving the common good in a meaningful and fundamentally tangible way. We as state and federal prosecutors are under no illusions that, through our prosecutions, we have waived a wand and the mob or drug problems, for example, are gone forever. But there is something uniquely gratifying about putting dangerous people in jail, and saving lives by preventing them from doing further future harm to others. I have, at least to this point, been willing to forgo material rewards to have that sense of satisfaction."

## Tell us a little about some of your other interesting cases.

"For example, these two come to mind:

The prosecution of Vincent McCaffrey, a Catholic priest accused of sexual abuse, had a positive outcome for the victims and their family members. I could see the rawness of their pain and their gratitude for justice being served. McCaffery, now 50, is serving 20 years in prison.

Then, there was the case of 500 pound Joe Kalady, who was involved in fraudulent document mill prior to

9-11, where he produced false documents - including counterfeit birth certificates - which his 'customers' then used to obtain U.S. passports. Kalady was caught and agreed to cooperate in a sort of 'going out of business sale' sting operations. Law enforcement officials installed cameras in and around around his business. They picked up customers from O'Hare Airport and took them to Kalady's house to wrap up all their dealings.

After the events of September 11, 2001, the seriousness of such a false document mill became all the more obvious, and it received increased attention.

Following the sting, and prior to Kalady's scheduled guilty plea, Kalady started to miss appointments with the court, citing medical excuses. Subsequently, Kalady's brother called police to his brother's apartment and showed them a dead man whom he claimed was Joe. On a hunch we drove to the Romeoville Crematorium where we discovered a box stenciled with the name Joe Kalady. The box unfortunately held the remains of William White - a homeless man who, as it was later found, had been brutally murdered by Kalady. Kalady's doctor in fact faked a death certificate for Joe. After a 72-hour manhunt, Kalady was found in a hotel room in Boston, attempting suicide."

#### How did you become a Pike?

"I met John Dugenske '85; 'Dewey' was the first person I met through some friends who had pledged at Bromley Hall. He and Martin Noven '87, both of whom I really liked, emphasized the desire to be successful socially and academically. They exemplified what I was looking for: an opportunity to have an active social life in the company of people with similar goals."

## What awards or positions did you hold when you were an undergraduate in the Fraternity?

"I don't believe I ran for or held any elected positions, but I received the Academic Award and Out of House Brother of the Year Award. I remember that my former roommate Brett Maher '89 was 'Partier of the Year' however, and he is doing a lot better financially than I am, so I'm not sure what that tells you." (Funk comments with a smile.)

## What was greatest thing you got out of being in the Fraternity?

"When I look at my network of friends, they are by and large my Fraternity brothers. You make bonds with people that simply stay with you throughout your life. There is something about being around people you basically have known since you yourself were a kid."

## What advice do you have for undergrads?

"Basically, stay out of trouble. There is something about a group of guys hanging out together that can sometimes lead to problems. That's just as true for football players, fraternity guys, or even 30-something-year-old alumni going on a 'guy vacation'. Tip of the day: Don't get a felony conviction. Remember that if a job requires a background check, even misdemeanors can come back to haunt you. I myself had a minor ticket at the U of I that actually delayed my starting as an Assistant United States Attorney."

#### And for alumni?

"Create real world learning and dialogue opportunities for undergrads who want to develop a sense of what they want to do with their lives, not just 'networking' opportunities."

#### What's next for T. Markus Funk?

"I am finishing up my work on 'Operation Family Secrets', and keeping myself busy writing several things: a handbook on Darfur for The American Bar Association (with funding from the MacArthur Foundation), and a book on how to prosecute in the International Criminal Court in The Hague, in particular. I'm working on a project in Kosovo on human trafficking. I could also see a future where I teach and write further down the road. But for now I am happy to be back working as a 'Line Assistant' in the U.S. Attorney's Office, having the privilege of prosecuting cases with some of the best attorneys in the nation."

I first met Markus shortly after he was initiated in the fall of 1988, on the night of my formal pledging. Having known him for nearly 20 years, I can attest to how fortunate Pi Kappa Alpha is to have such a unique individual among our alumni.





# On The Edge

Wilderness Adventures

by Richard D. Jackson (Marshall, Delta lota '57)





Within these covers are stories about a group of risk-takers and adrenaline junkies who lived a life of stimulating and challenging activity. It is a rollicking adventure account of men who chose a wilderness avocation and lifestyle in lieu of comfort and leisure for their relaxation.

This is also a travelogue about much of the backcountry of this nation. Their journeys into these wilderness areas lasted over twenty years comprising some seventy expeditions into places like the Everglades, Okefenokee Swamp, Appalachian Trail, Pesidential Range, and the desert of Joshua Tree. Learn about these locations and other backwoods areas, primarily in the mountain states of Colorado, Idaho, New Mexico, Montana, Utah, and Wyoming. Read about these unusual people and the physical trials they put their aging bodies through as they pursued their passion, searching for refuge from their work, and adventure in their lives to help calm their craving for fun and new experiences. Importantly, they wanted to be explorers and to see what was over the horizon. Their interest level had no valley and no summit. It was limitless. They were not purists in the sense of following the conventional standards of "roughing it" in the wilderness. Instead, they did it their way. They were the real thing and enjoyed living on the edge. Not many people do. There is humor, philosophy, lessons on field-craft, and dubious judgment noted in their journeys. These should appeal to all readers with similar inclinations despite age or gender.

Richard D. Jackson graduated from Marshall in 1959 with a BBA degree in marketing and retailing. He was a member of the Varsity Club and played varsity football, basketball, and ran track for three years.

Upon graduation, he entered the Marine Corps and was commissioned a second lieutenant and eventually was promoted to major.



During his eight years he served in Cuba during the missile crisis in 1962, in the Mediterranean as part of an alert force in readiness, Malaysia, Hawaii, and finally in Vietnam where he was awarded the Silver Star, the Nation's third highest decoration for Gallantry in Action, the Bronze Star for Heroism, and The Vietnam Cross of Gallantry.

He entered the banking industry in 1968 as a trainee for the First National Bank of Atlanta and after seven years moved to First Georgia Bank in 1974, also in Atlanta, as the president and CEO of that organization for 12 years.

He was then hired as the president and CEO of the largest Savings and Loan institution in Georgia, Georgia Federal, in 1986. He spent seven years at the helm of that organization until it was sold to First Union Corporation, as was First Georgia Bank when he departed earlier to accept the position at Georgia Federal Bank.

After that he was employed by First Financial Management Corporation, a \$1.5 billion sales information services company, also in Atlanta, as the chief operating officer and later as the Vice Chairman until he retired in 1995.

During his retirement years he authored several books. Yesterdays Are Forever, A Rite of Passage through the Marine Corps and Vietnam War; The Last Fast White Boy, a story about athletics at Marshall in various sports during the fifties; and a book on banking, Too Stupid To Quit, Banking and Business Lessons Learned the Hard Way, which was published by The Drinko Academy at Marshall University. That book will be used for textbook reference in the business school. It concerns the banking industry in Atlanta during the seventies; eighties and nineties, with lessons learned and applied during his career in sports, the Marine Corps, and business.

His latest book, On The Edge, is about wilderness adventures over a 25-year period involving some 75 expeditions into much of our nation's backcountry.

Jackson has established and funded an endowment in the business school at Marshall called the Richard D. Jackson Endowment for New Business Frontiers. All proceeds from the sale of his books are pledged to this Endowment and to other scholarship programs within the Marshall University Foundation.

All publications are available through various online book sellers.

Jackson has received three awards from Marshall, The Community Achievement Award in 1986, and in 2002 was inducted into the Business School Hall of Fame. He received a Doctor of Humane Letters honorary degree in 2005. He also received the Freedoms Foundation Literary Award in 1972.

During his business career he was a member of several organizations in Atlanta and was also a member of the World Wide Young President's Organization and Chief Executives Organization. He also served for several years as the president and member of the Marshall University Yeager Scholarship Foundation.

He now serves on two corporate boards of companies in Atlanta. He is currently chairman of e.bank Financial Services, a financial services company, and Schweitzer-Mauduit International Inc., a multi- national fine papers manufacturer.


### The Band







## **News of Bygone Days**

### 125 Years Ago - 1872

In 1872 the dues were dropped from fifty cents each month to twenty-five cents each month.

Meetings were the hub of the chapter life, so it is not surprising that such attention was lavished on the meeting room. In the first four years, no trouble was experienced in getting the brothers to meetings; occasional absences were fully explained. Quorum difficulties first showed up in March of 1872; shortly thereafter, fines for absence from meetings were introduced.

A concern was how to show respectful sorrow at the death of a brother. In January 1872, Alpha, after a brother's untimely death, voted to wear badges covered by a small patch of black crepe, a custom called "hatching".

### 100 Years Ago - 1907

During this time the typical chapter charged roughly fifteen dollars as an initiation fee. This included a two dollar Shield & Diamond subscription and five dollar fee to the General Fund of the Fraternity.

### 75 Years Ago - 1932

On August 22, 1932, Alpha lota, with the other Mississippi chapters, Gamma lota and Gamma Theta, sponsored the annual state-wide Pi Kappa Alpha dance. The National Guard armory, scene of the affair, was elaborately decorated in garnet and gold. About seven hundred Pikes, rushees and their dates enjoyed one of the best dances ever given in Jackson.

### 50 Years Ago - 1957

During this time, discussion at national meetings frequently turned to the necessity of, and training for, alumni advisors. By World War II, most chapters had the counselors and then the major issue was their training. Bringing the alumni to conferences, to the leadership schools and to the conventions was discussed but usually discarded. By 1957, Charles Freeman, then national treasurer, urged the development of a regular, biennial conference for alumnus counselors in Memphis.

### 25 Years Ago - 1982

At the 1982 Convention in Washington, D.C., important legislative actions included changing the voting requirement for expelling a member from two thirds of the active chapter to two thirds of the members present at the hearing; establishing a detailed list of regional vice president duties in the Constitution; raising initiation fees, pledge fees and annual dues; adding a new chapter to the Laws requiring all chapters to have adequate liability insurance coverage and adopting a proposal to establish a Fraternity alcohol awareness program.

successes. He would then use this information to help form and execute strategy. I take nothing away from Sam Walton's simple brilliance here and I make no claims to have invented this approach myself, but long before I read of this I practiced it in the chapter. As president, it occurred to me that if I wanted to understand why a particular faction of members was not interested in supporting certain activities or why there might be general apathy toward ideas, the best way for me to understand what was happening was to walk around the chapter house in the late afternoon or evening and poke my head into open rooms where groups of brothers were hanging out and listen to what was on their minds. It was amazing the things I learned.

These are but a few musings on how my Pike chapter experiences helped to prepare me for success as a business man. Lately my business life has me doing business development, with the focus on pulling together disparate companies into relationships through which they can achieve much more together, and in broader markets, than they could independently. In this endeavor I am learning the truth in the old adage "Other things being equal, people would rather do business with their friends." In fact I am starting to see that "other things being unequal people would still rather do business with their friends." This has me thinking about another potential book: All I Need to Know About Business Development I Learned in Rush. But that's a discussion for another time.

### Tommy E. Chesbro (Oklahoma State, Gamma Chi '88)

Tommy Chesbro, who wrestled for Oklahoma State before leading his alma mater to an NCAA championship as a coach, entered Chapter Eternal on August 31, 2007. As an athlete, Chesbro was a member of NCAA title teams in 1959 and 1961. After his graduation, he worked as a high school coach in Blackwell and Stillwater before becoming Oklahoma State's coach in 1970. In his second season at the OSU helm, he guided the Cowboys to their 27th national title and was named as the national coach of the year. In 15 seasons at Oklahoma State, he went 227-26 and added two NCAA runner-up finishes, in 1983 and 1984. He ended his coaching career on a 43-dual match winning streak. He coached 19 wrestlers who won individual NCAA titles and 76 All-Americans. One of his former wrestlers is John Smith, who went on to win two Olympic gold medals and is now the Cowboys' coach. After stepping down as coach, Chesbro spent the last 22 years working in facilities for Oklahoma State.

In 1995, Chesbro was inducted into the National Wrestling Hall of Fame.

### Harry S. Dent (Presbyterian, Mu '48)

Harry S. Dent, a former White House aide who helped devise the "Southern strategy" that was crucial to President Nixon winning the White House, entered Chapter Eternal on September 28, 2007.

He was a graduate of Presbyterian College, George Washington University School of Law, Georgetown University School of Law and Columbia International University. He held honorary doctorates from Charleston Southern University and Presbyterian College. Dent served as an infantry officer during the Korean War. He then went to work in Washington as an aide to Sen. Strom Thurmond, South Carolina Republican, for 11 years before serving as an aide to Presidents Nixon, Ford and George H.W. Bush. Dent started the first White House Prayer Breakfast in 1969.

He was a former chairman of the Republican Party in South Carolina, as well as a practicing lawyer. He was the founder of Laity: Alive and Serving, a ministry that took him across the United States and to many foreign countries. Dent was awarded an honorary citizenship from Romania for his work in Cluj, Romania; the Order of the Palmetto from South Carolina Govs. James B. Edwards and David M. Beasley; the Good Shepherd Award from the Boy Scouts of America; and the Salt and Light Award from the Southern Baptist Convention.

Dent was the first director of the Billy Graham Lay Center in Asheville, N.C., and was chairman of Mr. Graham's crusades in Columbia, S.C., and Charlotte, N.C. He also served as a trustee of Southern Seminary, Charleston Southern University and as a member of the executive committee of the Southern Baptist Convention. A room in the Manor House at Southeastern Seminary was named for him because of his work in lay ministry. He was a member of First Baptist Church of Columbia.

### Paul R. Flynn (Seton Hall, Eta Beta '87)



Paul R. Flynn entered Chapter Eternal on June 18, 2007. Born in January 1968 in Bronx, New York, Paul was 39 years of age. Surviving are his parents, Raymond and Anita Flynn of East Brunswick, New Jersey; two brothers and one sister.

Paul's professional life was a string of community service related ventures. All of which began with his first job at Seton Hall University as an associate in the development office. From there he went on to serve as the Assistant Director of Development at Seton Hall Law School – a position he held for 4 years and which allowed him to make Newark his permanent residence.

Paul served as the Director of Marketing and Community Outreach at Gateway Northwest Maternal and Child Network, a Newark, New Jersey based non-profit organization.

While at Gateway, Paul's focus was lead poisoning awareness – and marketing and championing "Leadie Eddie" a child-friendly icon. Childhood lead poisoning prevention became his passion. During his time with Gateway he also served as the Program Director of Community Lead Education and Remediation (CLEARCorps), an Americorps affiliate, and staff director of the Newark Partnership for Lead Safe Children.

Immediately prior to joining Gateway, Paul pursued two personal dreams. The first was to start a business (Volunteer Advantage) focused on increasing volunteerism among people of all ages. The second was to run for public office in Newark, New Jersey –Paul's own words for that time, and used in his campaign materials, are a great symbol of his character and his life. "Single voices singing may have trouble being heard, but there will be no disregarding the civic chorus of collective citizens." His campaign principles were Trust, Tolerance, Teamwork and Tenacity - all things that were important to Paul.

Before setting off on his entrepreneurial and political ventures, Paul served as the Executive Director of Charcot-Marie-Tooth Association, a non-profit organization dedicated to funding and advancing research for CMT, the most commonly inherited neurological disorder and is found world-wide in all races and ethnic groups.

Paul's social life also often revolved around community and charity. His civic interests included education, volunteerism, the City of Newark and Seton Hall University. While at Seton Hall University, he served as President of the Student Government Association and was an active member at Eta Beta Chapter, Paul was a founder and director of Jersey Cares - an organization created to increase and organize volunteer participation in all social sectors. He was an active volunteer with Discovery Charter School and a board member of Discovery Learning Fund and Link Community School, all Newark based organizations. Paul was a founder and director of the Leadership Newark Graduate Organization, the alumni arm of Leadership Newark - a two year community service and educational program dedicated to the

betterment of Newark and its leaders.

The Paul Flynn Memorial Scholarship has been established to honor the life of Paul Flynn, HB '87 - a man dedicated to the ideals of servant leadership. Early in his life Paul committed himself to helping others through his personal volunteerism and professional pursuits at various non-profits. Through Paul's efforts promoting the importance of community service and philanthropy, many people followed his example, and countless others received assistance.

The Paul Flynn Memorial Scholarship will be awarded annually to a student who can demonstrate both financial need and a commitment to community service. While all service is worthwhile and will be considered, a connection with Newark is not required, but will be of particular interest to the scholarship committee. Ongoing volunteerism is a condition of renewal, and awardees may reapply.

### Benjamin B. Graves (Mississippi, Gamma lota '42)



Dr. Benjamin Graves, the first president of The University of Alabama in Huntsville, entered Chapter Eternal on October 19, 2007. He was instrumental in establishing Pi Kappa Alpha on the UAH campus.

He served as president of the University of Alabama-

Huntsville after the University of Alabama System created autonomous campuses in Huntsville and Birmingham in 1969. He joined the university that year and led the university's growth until he stepped down in 1978.

When Graves came to the university, enrollment figures showed 2,173 undergraduates and 362 graduate students. When he stepped down as president in 1978, enrollment was 3,417 undergraduates and 549 graduate students. UAH's overall budget nearly quadrupled during his tenure – from \$4.8 million when Graves arrived to \$16.16 million in 1979. During his term, research rose from \$1.4 million in 1969 to \$2.3 million in 1978. Following his retirement, Graves returned to his first love – teaching. He resumed classroom instruction at UAH in management, finance, investments and marketing until 1989. He also lectured at LSU, Penn State, the University of Virginia and the University of North Carolina at Charlotte.

Before joining UAH, he served as president of Milsaps College in Jackson, Miss., from 1964 until 1969. His undergraduate degree was from the University of Mississippi, and he earned an MBA from Harvard Graduate School of Business Administration. His doctorate was from Louisiana State University. Dr. Graves also conducted postdoctoral work at the University of Chicago and Harvard University.

### Lemuel H. Johnson III (Texas, Beta Mu'43)



Lemuel Johnson entered Chapter Eternal on September 10, 2007. He proudly served his country and was a highly decorated bombardier with the 8th Air Force in World War II. Johnson was a charter member of Hillcrest Masonic

Lodge and among the first members of Creekwood UMC in Allen, Texas. He spent many years serving youth as a Scoutmaster, baseball coach and mentor. Johnson was a fun loving, outgoing and outspoken man who cared deeply for others and lived life fully.

# William D. Pennington (Tulsa, Gamma Upsilon '63)

William D. Pennington, president of Murray State College, entered Chapter Eternal on October 13, 2007 as the result of an automobile accident. Pennington became president of Murray State in 2004. Before then, he had been dean and professor of history at Northwestern Oklahoma State University's Enid campus, and before that he was the dean of humanities and social sciences at the main campus in Alva. Donna Graves, a spokeswoman for Murray State College, said Pennington was "instrumental in creating legacies for the college. His love and desire to restore the beauty, history and innovative progress of the college was a driving force of his administration."

Pennington received his bachelor's degree in history and secondary education from the University of Tulsa. He also received his master's degree in history from the University of Tulsa before going on to the University of Oklahoma, where he received his doctorate in history.

### John M. Scott (Western Reserve, Beta Epsilon '36)

John M. Scott, the CIA's operational directorate records chief for several years, entered Chapter Eternal on July 29, 2007. He attended Western Reserve University, where he was president of Beta Epsilon Chapter. He also attended Youngstown University, where he received his bachelor's degree. He did graduate work at both Western Reserve and Ohio State University and during this period, worked several years in the various departments of the American Shipbuilding Co. of Cleveland. Scott served in the Army during World War II in Panama, Guatemala and Germany, where he was chief of records for the Counter Intelligence Corps Headquarters. He remained active in the Army Reserve until 1977, when he retired as a lieutenant colonel. He joined the CIA in 1949, and was instrumental in developing a worldwide operational records system while also functioning as archivist for OSS Records. Travel for the Agency took him to Europe, the Middle East, Africa and the Far East. His duties included records liaison with the intelligence services of Canada, France, Great Britain, Japan, Egypt, Turkey, Greece and West Germany. Mr. Scott had a second duty tour in Germany and a final tour of duty in CIA Headquarters on the historical staff, where he authored several classified histories and assisted

numerous writers of CIA history. He was the recipient of the Honorable Service Medal and Certificate of Distinction and retired from the CIA in 1972.

In retirement, Scott was active in the Widewater Volunteer Fire Department in Stafford County, Virginia and helped establish the Widewater Rescue Squad. He served as chairman of the Stafford County Welfare Board, secretary of the local Architectural Review Board and was an active member of the Stafford Historical Society and Master Gardeners. He was a member of the Protestant Chapel Council at the Marine Corps Memorial Chapel, Quantico, and the Central Intelligence Agency Retirees Association.

### G. Thomas Shires (Texas, Beta Mu '43)

Dr. G. Thomas Shires entered Chapter Eternal on October 18, 2007. A physician and educator, he was instrumental in the events following the shooting death of President John F. Kennedy in 1963.

An hour after he learned of the shooting, Shires was at Parkland Memorial Hospital, where he would help save the life of Texas Gov. John Connally, shot in the same motorcade as the President. A surgery team operated on the governor, with Shires performing surgery on Connally's thigh wounds.

Two days later, he operated on Lee Harvey Oswald, the assassin, who had received a fatal abdominal wound. Oswald had been transported to the hospital in a hearse, with no intravenous fluids or trained paramedic, which Shires concluded led to his death. Subsequently, he worked with Dallas Fire Department officials to establish one of the nation's first mobile emergency medicine systems, having discovered that intravenous saline solutions were highly beneficial to trauma and surgical patients. His colleagues at UT Southwestern expanded the same research to create the Parkland Burn Formula, which is still used around the world today.

Shires attended the University of Texas at Austin, and in 1948, he received his medical degree at Southwestern Medical School, now UT Southwestern Medical Center at Dallas. He received the Ho Di Award, a coveted honor given to one member of each class.

He was an intern in Boston and a resident at Parkland hospital from 1950 to 1953, and served in the Navy aboard the hospital ship Haven before becoming a clinical instructor at the Dallas medical school in 1955. He became an assistant professor in 1957 and was later named associate professor. In 1961, he was named chairman of the surgery department.

In 1974, Shires left the Dallas medical school to work at the University of Washington School of Medicine in Seattle. The next year, he accepted a position as chairman of the department of surgery at Cornell University Medical College. He was named dean and provost for medical affairs at Cornell in 1987, and was professor emeritus at the time of his death. In 1991, he became chairman of surgery at Texas Tech University Health Sciences Center in Lubbock, and in 1997, moved to Nevada to be director of the trauma institute at the University of Nevada School of Medicine, a position he held at the time of his death.



### Christopher J. Worden (Wilfrid Laurier, Kappa Mu '98)



Too often I find that words like "hero", "courage", and "love" are used loosely when describing someone who has passed on. Today, however, those words stand up to their true meaning as Pi Kappa

Alpha mourns the passing of one of our own – a "gentle giant" who was taken from this world at too young an age.

At 5:00 a.m. on the morning of October 6, 2007 in the North West Territories, Wilfrid Laurier University Kappa Mu Chapter brother and federal officer of the Royal Canadian Mounted Police Christopher Worden was gunned down in the line of duty. On that cold, dark morning, Chris was single-handedly responding to a domestic disturbance call in a rural community, far into Canada's north.

Chris Worden was taken from this earth too early in life at the age of 30, and leaves behind his wife Jodie, an 8-month old daughter, Alexis, and an entire nation that mourns the loss of a hero who has paid the ultimate sacrifice while doing the job he loved.

We all remember Chris as a gentleman who, at 6 foot 3 inches and 240 pounds, had an imposing presence, yet was always wearing a wide and friendly grin. His RCMP partner described his common demeanour best during Chris' funeral service as a guy, "who had an infectious sense of humour".

A born leader, rising to captain of Laurier's nationally-ranked football team, and the eldest of four siblings, Chris was serious when it came to family, football, community, and academics. He was one of the most selfless individuals we knew, who made sure the word "FUN!" found its way into everything he did, and he made it a top priority to share that belief with everyone.

More than just an accomplished athlete and violin player, Chris lived life to its fullest and amazingly balanced his schedule of supporting Pike events, volunteering his time in the community, holding down a part time job as a bouncer, managing his duties as the editor of the University Yearbook Committee, all the while balancing the full time class load and high academic standards required of political science students at Wilfrid Laurier.

He was a virtual jack of all trades who did everything he applied himself toward amazingly well, fulfilling to the highest regard the true meaning of Scholar, Leader, Athlete and a Gentleman. Chris was one of those rare individuals who has been blessed with the gift of a warm heart, loving smile, and courageous spirit. And he was always one who took on the duty to make his surrounding community a better place for everyone.

Chris' younger sister put it best during the eulogy she delivered at his funeral in Ottawa, broadcast world-wide and attended by thousands of police officers, family, friends, and dignitaries, when she said. "We are here to focus on the living memory of Chris' life."

Her words, and her poise during its delivery, allowed strangers a great glimpse into the caliber of the person that made up Kappa Mu's gentle giant. That moment truly captured the essence of Constable Worden, who proudly served the interests of his fellow countrymen and women.

To Jodie and Alexis, and Chris' family, I, along with our entire Fraternity, extend our deepest condolences. May all that shined brightly in Chris resonate in his precious daughter. For all the gentlemen of Kappa Mu who knew Chris during his time at Laurier, we can honestly say that getting to know your husband and father, your brother and son, made our Pike community a better place.

To our brother, Chris Worden, and the long line of those who in their efforts to make our world a safer place to live, who also made the ultimate sacrifice... and to those among our PiKA ranks today who have dedicated themselves to being good stewards of humanity, we will always honour and cherish your memory, and be grateful for what you do.

# Remembering A True Giant

D. Mark Anderson (Wofford, Nu '76) 1956-2007

Pi Kappa Alpha lost one of its true giants on October 8, 2007, with the sudden passing of Mark Anderson. Mark left us in Asheville, North Carolina, at age 51. He is survived by his wife of nine years, Jane R. Orahood.

Most eulogies are written in the third person, as if observing dispassionately from afar. When I was asked to write Mark's eulogy for this magazine, I knew that I could only do so in an informal and somewhat personal way. Those of you who knew Mark, even if only

for a brief moment in time, surely understand. He was approachable, selfdeprecating, and never spoke of himself or his professional achievements. What mattered most to Mark were his friendships.

I first met Mark when he visited my chapter during my sophomore year. I still recall being amazed by his poise, confidence and stature. I knew right then that I wanted to be just like him. Mark embodied what it meant to be a "professional staff" Pike. There are a good number of us from that era who joined the Pike staff because we had the good fortune to meet Mark.

Mark's professional service on behalf of Pike was extensive. He served as a resident counselor at Zeta Rho (North Dakota) and later Beta Zeta (SMU). He went on to work as a chapter consultant, director of chapter services, and director of educational programming; in the latter role, Mark created the innovative summer leadership program now

known as the Academy. My fondest memories of my first year on the Pi Kappa Alpha staff were talks with Mark, who always found time to make each of the newbies feel welcome and special. Mark later told me that as he drove out of Memphis to end his time as a "professional Pike" and begin graduate business school at Emory University, he wept at the thought of leaving something he loved so dearly.

Typical of Mark, his involvement with the Fraternity didn't cease. He worked closely with Beta Kappa (Emory) while in graduate school, going on to serve for five years as chapter advisor. As news of Mark's death reverberated within our ranks, the response of Emory Pikes who had been students during Mark's tenure as CA was overwhelming. Illustrative are the words of Steven Gurdin '87: "When I reflect on my years at Emory and my two terms as president of the chapter, Mark quickly comes to mind. He was very devoted to our chapter. I can recall

some difficult days as chapter president and I could always pick up the phone and call Mark for guidance, support, wisdom and words of encouragement. I remember that Mark's work often required out of town travel but he always was available to the chapter and me."

Mark moved on from Emory to become Dixie regional president, and again proved a model for the role. He knew his chapter leaders and many members by name. Perhaps best to those of us who knew


him well, he never lost his exceptional good humor, even in times of stress (such as when he presided over the infamous "student falling through skylight onto salad bar" and "banquet in the registration lobby" fiascos that never failed to elicit a hearty laugh from Mark when we brought it up every year thereafter).

Elected to the Supreme Council as a vice president in 1996, 1998 and 2000, and as international president in 2002, Mark brought exceptional gifts to the role. He redirected the Council's energies to policy-making on a broad scale, culminating in the Return to Values initiative that Mark personally championed. At the time of his death, he was serving as a trustee on the board of our Educational Foundation. Mark changed Pi Kappa Alpha for the better. I had the honor of introducing him to the 2002 Convention as our president, and of pinning the past president's pin on him at the 2004 Convention. I will always be

grateful for those moments with him.

To know Mark was to laugh often. When he went out on his own professionally to start Anderson & Associates, I facetiously asked him why my caller ID showed "Kroger payphone" when he called from his new office. Mark picked right up on the joke, interrupting our call repeatedly to talk with imaginary fellow shoppers. Following his election in 2002, he would begin any call to me by saying "Please hold for your international president," followed by a pause to allow for sufficient respect. I cannot recall a conversation with Mark that did not end up with laughter, and I will long cherish how fortunate I was to have him in my life.

When news of Mark's death traveled through our fraternal family, the first reaction of virtually all was that we had lost the nicest guy any of us had ever met. He had a booming laugh and

the broadest smile I have seen. Mark was unfailingly happy and the ultimate friend. He never failed to call me on my birthday during the 25 years that we were best friends. He was there at every critical life event for many of us, attending my now 17 year old nephew's christening in 1988 and rushing to Arkansas to stand at Pat Haynes' side for his mother's funeral in 2004. Mark was the first person I called when I was offered the chance to return to academic life at UVA, and he spent hours with me talking it through. I learned after his death that he had performed a similar unselfish service to Andy Morse as he wrestled with career change last year. If you needed a friend to listen, care and advise with unconditional love, you looked to Mark.

He called each of us "Bud," and we knew exactly what that meant.

D. Mark Anderson, 51, of Atlanta,
Georgia, the president and founder of
Anderson and Associates, died October
8, 2007, after suffering a sudden and
massive stroke. He was born on June 14,
1956, in Union, South Carolina. He earned
a bachelor of arts degree from Wofford
College in Spartanburg, South Carolina,
where he was a Blue Key Honor Scholar, and
a master of business administration degree
from the Goizueta Business School at Emory
University in Atlanta, Georgia, where he
received the Emory Fellowship Award.

For more than 20 years, he provided consulting services to nonprofit organizations throughout the country, which enabled schools, churches and other entities to enhance and better their communities. Parents throughout the Southeast have expressed that their children's schools enjoy facilities and opportunities today which would not exist without Anderson's work. Congregations throughout the Carolinas feel that not only

have their outdated buildings been rebuilt and restored to vibrancy once again due to his efforts, but also that the entire spirit of their churches has been rejuvenated. Wofford College credits his professional work on its behalf for the increase Wofford has enjoyed in meeting scholarship needs for its students.

Anderson was elected to the board of directors of the Mental Health Association of Metropolitan Atlanta, and also served as a Big Brother in Big Brothers of America. During his term as Pi Kappa Alpha's international president, he created the Return to Values Initiative to focus on guiding and mentoring young men on what it means to be a good man in every aspect of their lives. Anderson had served the Fraternity as international vice president, a member of the Educational Foundation's board of trustees, a member of the International Alumni Commission, Dixie regional president, chapter advisor to Beta Kappa (Emory) and as a member of the Fraternity's staff. He was a member of the Pi Kappa Alpha Educational Foundation's Oak Trust, Sabre & Key Society, and President's

Council. His own Nu Chapter at Wofford College established an award in his name which is presented annually to the brother who best exemplifies his philosophy of leadership and commitment of service to others.

Anderson was an avid athlete who swam competitively in Masters events and who competed in triathlons. He was an accomplished snow skier and enjoyed traveling to his log home in Colorado with his wife and friends. His vibrant personality and reassuring voice provided a wonderful stage for his passion for radio, where he was once a disc jockey, and his gentle and nurturing manner led to a deep love and concern for animals, especially for his dog Nutmeg.

He is survived by his wife, Jane R. Orahood, his mother, Marion A. Jennings, and two brothers, Thomas G. Anderson and William E. Anderson, as well as several nieces and nephews.
